RESOLUTION NO. 2020-020-A

**RESOLUTION REQUIRING CERTIFICATE OF CONFIRMATION FROM THE RECEIVING LGUs AND
NEGATIVE RT-PCR TEST RESULT AMONG INBOUND LSIS OF REGION 12**

WHEREAS, the Inter-agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) issued Resolution No. 50-A on June 29, 2020 placing the entire SOCCSKSARGEN Region under Modified General Community Quarantine (MGCQ);

WHEREAS, DOH-CHD XII COVID-19 Tracker revealed that the Region, as of July 7, 2020, has seventy-eight (78) confirmed patients, two of whom died, forty four (44) have fully recovered, and thirty two (32) are still on a quarantine. Among the infected patients, fifty (50) or 64.1% are ROFs and LSIs. Also, the remaining active cases are composed of thirteen (13) ROFs, eighteen (18) LSIs, and one with travel history in Davao City;

WHEREAS, the Office of the President, through the Presidential Management Staff, launched the Hatid Tulong Program to facilitate transportation and sending of strandeds from Luzon to their respective Provinces. For Region XII, more than six hundred individuals were assisted during the grand send-off on June 4, 2020;

WHEREAS, the resumption of the commercial flights and the organized sweeper flights allow the LSIs who are mostly coming from high-risk areas to finally return to their domiciles making the entire Region vulnerable to possible local transmission of the virus;

WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the LCEs reiterated that the LSIs must be required to secure negative result of RT-PCR Test and the certificate of confirmation from the receiving LGUs to ensure that they are fit to travel and are bonafide residents of Region XII. These measures are aimed to control the spike of confirmed COVID-19 cases and prevent possible local transmission;

WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized, and resolved emerging local issues and determine appropriate or future actions to avoid the further spreading of the virus;


NOW, THEREFORE, on motion of Gov. Steve C. Solon of Sarangani Province and duly seconded by RD Teresita Socorro Ramos of NEDA XII; **BE IT RESOLVED**, as it is hereby resolved, to Require Certificate of Confirmation from the Receiving LGUs and Negative RT-PCR Test Result Among Inbound LSIs of Region 12;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the National IATF-EID, NTF COVID-19, Provincial Governors, City and Municipal Mayors of Region XII, for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19 for their information and/or appropriate action.


