**RESOLUTION REQUIRING THE OUTBOUND LSIs TO SECURE MEDICAL CERTIFICATE,
TRAVEL AUTHORITY AND NEGATIVE RAPID TEST RESULT TO AVAIL THE
HATID TULONG BUSES IN TRANSIT TO MANILA**

WHEREAS, the Inter-agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) issued Resolution No. 50-A on June 29, 2020 placing the entire SOCCSKSARGEN Region under Modified General Community Quarantine (MGCQ);

WHEREAS, DOH-CHD XII COVID-19 Tracker revealed that the Region, as of July 7, 2020, has seventy-eight (78) confirmed patients, two of whom died, forty four (44) have fully recovered, and thirty two (32) are still on a quarantine. Among the infected patients, fifty (50) or 64.1% are ROFs and LSIs. Also, the remaining active cases are composed of thirteen (13) ROFs, eighteen (18) LSIs, and one with travel history in Davao City;

WHEREAS, the Office of the President, through the Presidential Management Staff, launched the Hatid Tulong Program to facilitate transportation and sending of strandedees from Luzon to their respective Provinces. The private buses commissioned by the PMS are expected to transport more than 600 strandedees of Region XII on July 7-8, 2020. The same buses are scheduled to depart and return to NCR on June 9, 2020;

WHEREAS, to maximize the available resources, PMS allowed the back loading of the buses which are capable of transporting 480 LSIs to Bicol, CALABARZON and National Capital Region;

WHEREAS, the DILG XII, as the Task Group Leader of the Management of LSIs, profiled fifteen (15) strandedees bound to CALABARZON Region, five strandedees bound to Bicol Region and one-hundred nine (109) strandedees bound to National Capital Region. These individuals had been waiting for transportation assistance in order to return to their home Regions since June, 2020;

WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body strongly supported the Hatid Tulong initiative and agreed on some protocols that are to be observed by Outbound LSIs to ensure health and safety of everyone on board these buses;

NOW, THEREFORE, on motion of RD Teresita Socorro Ramos of NEDA XII and duly seconded by Atty. Servillano Santiago Lorenzo III of DOJ-PAO XII and RD Macario D. Gonzaga of LTO XII; **BE IT RESOLVED**, as it is hereby resolved, to Require the Outbound LSIs to Secure Medical Certificate, Travel Authority, and Negative Rapid Test Result to Avail the Hatid Tulong Buses in Transit in Manila;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the National IATF-EID, NTF COVID-19, Provincial Governors, City and Municipal Mayors of Region XII, for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19 for their information and/or appropriate action.


