RESOLUTION NO. 2020-002
Series of 2020

A RESOLUTION REQUESTING THE NATIONAL BUREAU OF INVESTIGATION, PNP-REGIONAL CRIME LABORATORY, DEPARTMENT OF HEALTH, AND BUREAU OF FIRE-SRU TO CONDUCT FACE-TO-FACE ORIENTATION TO FUNERAL WORKERS IN HANDLING COVID-19 POSITIVE AND PUI REMAINS

WHEREAS, Presidential Proclamation No. 922 Series of 2020 declared the Philippines under the State of Public Health Emergency due to CoVID-19 and called upon all government agencies including local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the CoVID-19 threat;

WHEREAS, by virtue of Presidential Proclamation No. 929 Series of 2020, the Philippines was also declared under the State of Calamity due to the CoVID-19;

WHEREAS, as of April 6, 2020 there have been recorded 11 deaths, 10 PUIs and 1 CoVID-19 positive, for Region XII;

WHEREAS, the Department of the Interior and Local Government, as the lead agency of the Management of the Dead and Missing Cluster, has formulated the Interim Guidelines on the Management of Human Remains for Patient Under Investigation (PUI) and Confirmed Coronavirus Disease 2019 Cases under Memorandum Circular 2020-063 Series of 2020;

WHEREAS, under Memorandum Circular 2020-063, the universal, standard and transmission-based precautions and DOH-recommended guidelines shall be observed in handling the remains of COVID-19 cases and PUIs;

WHEREAS, under the same DILG Guideline, the LGUs are tasked to designate and commission reputable funeral parlors and crematoriums to handle the remains of confirmed COVID-19 cases and PUIs, and for funeral parlors and crematoriums to provide logistics and transport thereof;

WHEREAS, it further provides that, the PNP Crime Laboratory and/or National Bureau of Investigation shall provide technical assistance on the orientation of funeral workers about universal, standard and transmission-based precautions;

NOW, WHEREFORE, upon motion of **RD Josephine Cabrido-Leysa, CESO III**, DILG XII and seconded by **Mayor Cynthia Guiani-Sayadi**, Cotabato City, resolve as it is hereby **RESOLVED** to **REQUEST THE NATIONAL BUREAU OF INVESTIGATION, PNP-REGIONAL CRIME LABORATORY, DEPARTMENT OF HEALTH, AND BUREAU OF FIRE-SRU TO CONDUCT FACE-TO-FACE ORIENTATION TO FUNERAL WORKERS IN HANDLING COVID-19 POSITIVE AND PUI REMAINS;**

RESOLVED FURTHER that a copy of this resolution be forwarded to all the Regional IATG Members, the Regional Task Force on CoVID-19 Members, the Management of the Dead



and Missing Cluster members, and the local government units within the region for their information and immediate action.
