RESOLUTION NO. 2020-006 Series of 2020

A RESOLUTION ENJOINING REGION 12 LGUs TO EXTEND THE ENHANCED COMMUNITY QUARANTINE (ECQ) UNTIL APRIL 30, 2020.

WHEREAS, Presidential Proclamation No. 922 dated March 8, 2020 was issued by President Rodrigo Roa Duterte, declaring a State of Public Health Emergency throughout the Philippines. Section 4 of said Proclamation also provides that all citizens, residents, tourists and establishment owners are urged to act within the bounds of the law and to comply with lawful directives and advisories issued by appropriate government agencies to prevent further transmission of the COVID-19 and ensure the safety and well-being of all;

WHEREAS, on March 16, 2020, President Rodrigo Duterte declared the entire Luzon under "enhanced community quarantine" (ECQ). Subsequently, the Regional Task Force on COVID-19 XII was organized and convened on March 18, 2020 to address the call of the President. On its part, RTF CoVID-19 XII approved Resolution No. 2020-06 strongly urging the LGUs in Region 12 to implement General Community Quarantine to prevent the threat of further spreading of COVID-19;

WHEREAS, the DOH reported that as of April 6, 2020 the death toll has raised to 163 while the number of infections nationwide climbed to 3,660. Given this data, the national government, through the IATF-EID, informed the public that there is an "emerging consensus" among government officials, medical experts and the business sectors for the extension of the enhanced community quarantine in the Island of Luzon until April 30, 2020;

WHEREAS, in Region 12, as of 5PM of April 6, 2020, the DOH-CHD 12 reported a total of 10 deaths, 10 confirmed cases and 83 PUIs. The 10 confirmed cases reflected only those being tested by RITM, hence, possible community transmission. This scenario has caused worry and sincere concern, prompting local authorities to recommend this measure, pending the massive testing among PUIs and PUMs;

WHEREAS, during its Joint Meeting on April 7, 2020, the Regional Inter-Agency Task Group on Emerging Infectious Disease (RIATG-EID), the Regional Task Force on COVID-19 (RTF CoVID-19 XII), and the MDM Cluster, unanimously agreed to impose Enhanced Community Quarantine in their respective jurisdictions until April 30, 2020;

NOW, WHEREFORE, upon motion of Hon. Reynaldo S. Tamayo, Jr. Governor of South Cotabato, and duly seconded by Hon. Steve C. Solon, Governor of Sarangani Province, resolve as it is hereby RESOLVED, to ENJOIN REGION 12 LOCAL GOVERNMENT UNITS (LGUs) TO EXTEND THE ENHANCED COMMUNITY QUARANTINE (ECQ) UNTIL APRIL 30, 2020.

RESOLVED FURTHER that a copy of this resolution be forwarded to all the Regional IATG Members, the Regional Task Force on CoVID-19, the Management of the Dead and Missing Cluster members, and the local government units within the region for their information and immediate action.
