RESOLUTION NO. 2020-012

**POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE
MANAGEMENT OF CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION
12**

WHEREAS, on April 23, 2020, the Inter-Agency Task Force issued Resolution No. 28 which provides that all moderate and low-risk administrative regions, provinces or areas, a General Community Quarantine (GCQ) shall be implemented starting May 1, 2020 provided that the minimum health standards shall be strictly observed. It also provides that for low risk regions, provinces or areas, the GCQ shall be lifted by May 15, 2020 should there be no change in the risk level occurs. The Resolution also provides guidelines for the areas placed under the GCQ;

WHEREAS, during the April 24, 2020 Joint Meeting of the RIATG-12-RTF COVID-19 and MDM Cluster, it was agreed that the four (4) Provincial Governors, two (2) City Mayors shall harmonize their respective Executive Orders in relation to the policies and guidelines to be implemented after April 30, 2020 and the formulation of the LGUs' Economic Re-Start Plans

WHEREAS, among the major concerns of the LCEs and regional line agencies of Region 12 are the transit/repatriation and testing of the stranded constituents of Region 12 in the various parts of the country or along the regional borders, the absence of a certified testing facility within the region and how to re-start the economic activities without endangering the lives of people after the lifting of the ECQ on April 30, 2020 and during the implementation of the GCQ;

WHEREAS, in the Executive Session conducted by Governors, City Mayors with DOH, DILG and OCD on April 29, 2020, the LCEs of Region 12 discussed appropriate strategies and interventions for implementation during the General Community Quarantine (GCQ) in Region 12 starting May 1, 2020 for possible adoption of RIATG-EID 12 and RTF COVID-19;

NOW, THEREFORE, on motion of PBGEN BERNARD CASAS TAMBAOAN and duly seconded by PSR ALFREDO P. HEBRONA, JR. of RDC XII; **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the Joint RIATG-EID12, RTF-COVID-19 and MDM Cluster approve the following Resolutions:

1. Requesting the National IATF-EID to authorize the RIATG-EID 12 /RTF on COVID-19 for a Regional Border Lockdown from May 1- July 31, 2020 and to authorize the Governors/City Mayors for Provincial/City Border Lockdown on May 1-31, 2020;
2. Requesting IATF-EID to Repatriate Stranded Constituents of Region 12 in various parts of the country subject to NIATF guidelines and Minimum Health Standards set by DOH
3. Allowing the Transit of Stranded in the Borders of Region XII subject to Minimum Health Standards and LGU Protocols;

Special Considerations for Resolutions 2 & 3

- Host LGU to issue Certification that the 14-day quarantine has been undertaken (Health Clearance);
 - Receiving LGUs to enforce their protocols and fetch the stranded. No relatives to fetch them will be allowed;
 - Triaging to be established at the Borders by the respective PESU;
 - Repatriated individuals to be regularly and strictly monitored by the BHERTs in isolation centers, quarantine facilities or their respective homes;
 - Subject to other LGU standards and protocols;
4. Supporting the Request of LGUs Cotabato City, General Santos City, Arakan, Carmen, Magpet, Makilala, Matalam, Mlang, Midsayap, Pikit and Tulunan of Province of Cotabato; City of Koronadal, Banga, Lake Sebu, T'boli and Tupi, of South Cotabato Province; and Isulan and President Quirino of Sultan Kudarat Province for the Extension of SAP Implementation After April 30, 2020;
 5. Adopting the Economy Re-start Plan of Region XII;
 6. Endorsing to National IATF-EID the Local Economy Restart Plan of Region XII for information and approval;
 7. Requesting Philippine Business for Social Progress (PBSP) to Allow South Cotabato use 1 out of the 3 GeneXpert Machines for TB-DOTS for CoVid-19 Testing; and

8. Requesting PBSP to Provide the Testing Kits for South Cotabato;

9. AGREEMENTS AND INSTRUCTIONS:

- 9.1. Organize a meeting with the IT personnel of each Province to undertake a briefing of the Contact Tracing System of South Cotabato on Monday, May 4, 2020, 1:30 PM;
- 9.2. The 300 pcs of Face Masks from DTI 12 will be distributed to the 4 provinces and 2 Cities at 50 pcs each;
- 9.3. LGU South Cotabato thru the RTF Secretariat to provide NEDA 12 of a copy of LGU's Economic Re-Start Plan; and
- 9.4. For habal-habal operation, RD Leysa to communicate with higher authorities.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Inter-Agency Task Force on Emerging Infectious Disease (IATF-EID), National Task Force on COVID-19, members of the RIATG-EID 12, RTF COVID-19 and MDM Cluster for their consideration and immediate approval.


