A RESOLUTION SUPPORTING THE DSWD XII'S SOCIAL AMELIORATION PROGRAM FOR LGUs AND ENJOINING LGUs TO FACILITATE ITS SPEEDY, TRANSPARENT AND ACCOUNTABLE IMPLEMENTATION

WHEREAS, Resolution No. 11, , Series of 2020 issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) on March 12, 2020, raised the COVID-19 threat to the highest alert level, Code Red Sublevel 2, due to the evidence of sustained community transmission of the disease;

WHEREAS, Republic Act No. 11469 otherwise known as "Bayanihan to Heal As One" Act Section 4. (c) Provide an emergency subsidy to around (18) million low income households: Provided, that the subsidy shall amount to a minimum of Five thousand pesos (5,000.00) to a maximum of Eight

thousand pesos (8,000.00) a month for two (2) months; Provided, further, that the subsidy shall be computed based on the prevailing regional minimum wage rates and that the subsidy received from the current conditional cash transfer program and rice subsidy shall be taken into consideration in the computation of the emergency subsidy as provided for in the said Act;

WHEREAS, the Regional Inter-Agency Task Group convened on April 01, 2020 in compliance with Executive Order No. 168, series of 2014 and one of the actions taken by the Body was to support the implementation of DSWD XII's Social Amelioration Program which shall be implemented through a MOA with the LGUs;

WHEREFORE, on motion of DILG XII Regional Director Josephine Cabrido-Leysa, CESO III, duly seconded by Gen. Alfred S. Corpus of PNP XII, the Body;

RESOLVE AS IT IS HEREBY RESOLVED that the Regional Inter-Agency Task Group on MEID is supporting the DSWD XII's Social Amelioration Program for LGUs and Enjoins LGUs to Facilitate the Speedy, Transparent, and Accountable implementation.

RESOLVED FURTHER that a copy of the said resolution be furnished to all members of the Regional IATG, all the Regional Task Force on COVID-19 thru Gov. Suharto Mangudadatu, Chairperson for their support, Local Government Units and the Secretary of the Interior and the Local Government, for their information reference and appropriate action;
