**RESOLUTION NO. 02-2020
 Series of 2020**

A RESOLUTION ADOPTING THE STRUCTURE OF THE REGIONAL TASK FORCE ON COVID-19 AS APPROVED BY THE RPOC-RDRRMC DURING THE MARCH 18, 2020 MEETING TO INCLUDE THE DEPARTMENT OF AGRICULTURE (DA) 12, LAND AND TRANSPORTATION OFFICE (LTO) 12, PRESIDENTIAL MANAGEMENT STAFF (PMS) 12, AND PHILIPPINE COAST GUARD (PCG)

WHEREAS, Presidential Proclamation No. 922 Series of 2020 declared the Philippines under the State of Public Health Emergency due to CoVID-19 and called upon all government agencies including local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the CoVID-19 threat;

WHEREAS, Executive Order No. 168 Series of 2014 provides for the creation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases in the Philippines;

WHEREAS, pursuant to IATF Resolution No. 14 Series of 2020 paragraph G provides that "the IATF hereby organizes the Response Cluster and Incident Management Team (IMT) at the National, Regional and Local levels. The Department of Health (DOH) shall be the overall lead for the response clusters while

the Department of the Interior and Local Government (DILG) Interior Sector will be the overall lead for the IMTs”;

WHEREAS, pursuant to IATF Resolution No. 14, **Regional Inter-Agency Task Groups for the Management of Emerging Infectious Diseases (IATG-MEID)** are hereby organized in all regions headed by the Regional Directors of DOH;

WHEREAS, a Regional Task Force on COVID-19 was already established in Region XII pursuant to Joint RPOC-RDRRMC Resolution No. 05-2020 as a mechanism to curtail the spread of CoVID and as linkage between and among the local government units and the national government agencies;

WHEREAS, efforts has been initiated by the said Task Force which facilitated the resolution of issues and concerns during the implementation of the community quarantine between and among the different local government units in the Region;

NOW, WHEREFORE, upon motion of RD Josephine Cabrido-Leysa, CESO III, DILG XII and seconded by RD Alfred Corpus, PRO XII, resolve as it is hereby **RESOLVED** to **ADOPT THE STRUCTURE OF THE REGIONAL TASK FORCE ON COVID-19 AS APPROVED BY THE RPOC-RDRRMC DURING THE MARCH 18, 2020 MEETING TO INCLUDE THE DEPARTMENT OF AGRICULTURE (DA) 12, LAND AND TRANSPORTATION OFFICE (LTO) 12, PRESIDENTIAL MANAGEMENT STAFF (PMS) 12, AND PHILIPPINE COAST GUARD (PCG);**

RESOLVE FURTHER that a copy of the said resolution be forwarded to all the Regional IATG Members, the Regional Task Force on CoVID-19, and the local government units within the region for their information and reference;


