## RESOLUTION NO. 03-2020 Series of 2020

RESOLUTION SEEKING IMMEDIATE FINANCIAL AND TECHNICAL SUPPORT FROM THE NATIONAL GOVERNMENT THRU DOH FOR THE FULL OPERATIONALIZATION OF THE COTABATO REGIONAL MEDICAL CENTER, COTABATO CITY AS AN ACCREDITED TESTING FACILITY FOR COVID-19

**WHEREAS**, Section 15, Article II of the Philippine Constitution provides that the State shall protect and promote the right to health of every Filipino people;

WHEREAS, Presidential Proclamation No. 922 dated March 8, 2020 issued by President Rodrigo Roa Duterte, declaring a State of Public Health Emergency throughout the Philippines to address the threat due to the COVID-19 outbreak requires multi-stakeholder's pro-active actions;

WHEREAS, as of April 1, 2020, there are only 6 hospitals /molecular laboratories that were certified and authorized by DOH to conduct Diagnostic Tests, these are the Research Institute for Tropical Medicine (RITM); Baguio General Hospital Medical Center (BGHMC); San Lazaro Hospital (SLH); Vicente Sotto Memorial Medical Center (VSSMC); Western Visayas Medical Center (WVMC); and Southern Philippines Medical Center



(SPMC) which is located in Davao City, Region 11. As of this time, Cotabato Regional and Medical Center is yet to undergo several stages to be fully accredited as one;

WHEREAS, to facilitate the immediate and fast identification of COVID cases in the region, the Regional Inter-Agency Task Group on Emerging Infectious Disease (RIATG-EID) in Region 12 finds it necessary that a testing laboratory for CoVid-19 be operationalized in the soonest possible time. The Cotabato Regional and Medical Center is a tertiary government hospital under the Department of Health, situated at Sinsuat Avenue, Rosary Heights X, Cotabato City.

NOW, WHEREFORE, upon motion of RD Macario D. Gonzaga, LTO XII and duly seconded by RD Josephine Cabrido-Leysa, CESO III, DILG XII and RD Alfred S. Corpus, PRO XII, resolve as it is hereby RESOLVED, that the REGIONAL INTER-AGENCY TASK GROUP ON EMERGING INFECTIOUS DISEASE (RIATG-EID)-12 SEEKS THE IMMEDIATE FINANCIAL AND TECHNICAL SUPPORT FROM THE NATIONAL GOVERNMENT THRU DOH FOR THE FULL OPERATIONALIZATION OF THE COTABATO REGIONAL MEDICAL CENTER, COTABATO CITY AS AN ACCREDITED TESTING FACILITY FOR COVID-19:
