## RESOLUTION NO. 07-2020 Series of 2020

A RESOLUTION FAVOURABLY ENDORSING THE REQUEST OF MAHINTANA FOUNDATION, INC.
TO SECURE A LANDING PERMIT FROM GENERAL SANTOS AIRPORT/CIVIL AVIATION
AUTHORITY FOR THE SPEEDY DELIVERY OF MEDICAL EQUIPMENTS AND SUPPLIES IN SELECT
HOSPITALS IN SOUTH COTABATO FOR COVID-19 TREATMENT

WHEREAS, Presidential Proclamation No. 922 Series of 2020 declared the Philippines under the State of Public Health Emergency due to CoVID-19 and called upon all government agencies including local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the CoVID-19 threat:

WHEREAS, Executive Order No. 186 Series of 2014 provides for the creation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases in the Philippines and creation of the Regional Task Groups (RIATG) as resolved in IATF Resolution No. 14, Series of 2020 as policy-making body;

WHEREAS, pursuant to RPOC-RDDRMC Resolution No. 5, Series of 2020, the Regional Task Force on CoVID-19 was created and was adopted by the Regional Inter-Agency Task Group on Emerging Infectious Diseases as a coordinating mechanism in order to address operational concerns;

WHEREAS, there is a pro-active partnership between the government and multi-stakeholders;

**WHEREAS**, the Mahintana Foundation, Inc., as one of the active NGO partners of LGUs in Region 12, has acquired hospital equipment and supplies for select hospitals in the region to be airlifted via General Santos Airport,

**WHEREAS**, the Mahintana Foundation requests the support of the Regional Task Force on CoVID-19 for facilitation of their request;

NOW, WHEREFORE, upon motion of RD Josephine Cabrido-Leysa, CESO III, and jointly seconded by RD Alfred Corpuz of PRO XII and Alfredo Hebrona, Private Sector Representative, RESOLVE as it is hereby RESOLVED to FAVOURABLY ENDORSE THE REQUEST OF MAHINTANA FOUNDATION, INC. TO SECURE A LANDING PERMIT FROM GENERAL SANTOS AIRPORT/ CIVIL AVIATION AUTHORITY FOR THE SPEEDY DELIVERY OF MEDICAL EQUIPMENTS AND SUPPLIES IN SELECT HOSPITALS IN SOUTH COTABATO FOR COVID-19 TREATMENT.
