A RESOLUTION ADOPTING THE RIATG-EID RESOLUTION NO. 01-2020 S. 2020
SUPPORTING THE DSWD XII'S SOCIAL AMELIORATION PROGRAM (SAP) FOR LGUs AND
ENJOINING LGUs TO FACILITATE ITS SPEEDY, TRANSPARENT AND ACCOUNTABLE
IMPLEMENTATION

WHEREAS, Resolution No. 11, , Series of 2020 issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) on March 12, 2020, raised the COVID-19 threat to the highest alert level, Code Red Sublevel 2, due to the evidence of sustained community transmission of the disease;

WHEREAS, Republic Act No. 11469 otherwise known as "Bayanihan to Heal As One" Act Section 4. (c) Provides for an emergency subsidy to around (18) million low income households: Provided, that the subsidy shall amount to a minimum of Five thousand pesos (5,000.00) to a maximum of Eight thousand pesos (8,000.00) a month for two (2) months: Provided, further, that the subsidy shall be computed based on the prevailing regional minimum wage rates: Provided, finally, that the subsidy received from the current conditional cash transfer program and rice subsidy shall be taken into consideration in the computation of the emergency subsidy as provided for in the said Act;

WHEREAS, Executive Order No. 168, series of 2014 mandates the creation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases in the Philippines, and following the guidelines set forth by IATF Resolution No. 14. Hence, the Regional Inter-Agency Task Group for Emerging Infectious Disease (RIATG-EID) 12 was created by virtue of Resolution No. 03-2020 series of 2020 dated April 1, 2020;

WHEREAS, one of the Resolutions passed during the RIATG-EID 12 meeting last April 1, 2002 was Resolution No. 01-2020 s. 2020 supporting the SAP for LGUs and enjoining LGUs to facilitate its speedy, transparent and accountable implementation;

WHEREAS, to ensure its operability at the LGU level, the Region 12 Task Force on COVID-19, deemed it important and proper to adopt the said resolution and its full implementation to all LGUs in Region 12;

WHEREFORE, upon motion of DILG XII Regional Director Josephine Cabrido-Leysa, CESO III, duly seconded by Gen. Alfred S. Corpus of PNP XII;

RESOLVE AS IT IS HEREBY RESOLVED that the Region 12 Task Force on COVID-19 is adopting the RIATG-EID 12 Resolution No. 01-2020 s. 2020 dated April 1, 2020 entitled "A RESOLUTION SUPPORTING THE DSWD XII'S SOCIAL AMELIORATION PROGRAM FOR LGUS AND ENJOINS LGUS TO FACILITATE THE SPEEDY, TRANSPARENT, AND ACCOUNTABLE SAP IMPLEMENTATION";





RESOLVED FURTHER, that a copy of this Resolution be furnished to all Regional Task Force on COVID-19 Members, all Regional IATG Members, and Local Government Units of Region XII, for their information, reference and appropriate action.


