22ND NATIONAL CONGRESS AND ELECTION OF NATIONAL EXECUTIVE

COUNCIL OF THE NATIONAL MOVEMENT OF YOUNG LEGISLATORS

The National Movement of Young Legislators (NMYL) will be holding their 22nd National Congress and Election of National Executive Council on February 23-25, 2017 at the Marriott Grand Ballroom, Pasay City.

As represented, for member-participants to develop and heighten their political maturity and responsible citizenship and effect positive change through legislation geared towards improving the lives of the people, the following will be conducted during the Congress: a) Presentations on the Philippine Youth Development Plan, Busog, Lusog, Talino and Ten Accomplished Youth Organization; b) Town Hall Discussion on Boosting Agriculture and Rural Development; and c) Fora on Federalism as a Better System of Governance for the Philippines and Legislation as a Powerful Tool for Social Change and Development. Likewise, at the end of the Congress, the NMYL is expected to have elected their new set of National Officers for the term 2016-2019, who will push the ideals and advocacies of the Movement.

In view of the above, and upon the request of Councilor Marlon Paulo C. Alejandrino, Valenzuela City and NMYL Interim National President, all Local Chief Executives are encouraged to allow the participation of their Vice-Governors, Vice-Mayors, Provincial Board Members, City/Municipal Councilors including the Presidents of Liga ng mga Barangay who are members of the NMYL in the above-mentioned activity, on official business.

The payment of traveling expenses and registration fee, if any, to cover the cost of hotel accommodation, meals and assembly materials, per participant, may be authorized in accordance with, and subject to applicable limitations prescribed in COA Circular No. 2012-003 dated October 29, 2012, chargeable against available local funds and to the usual accounting and auditing requirements, and to all pertinent laws, rules and regulations.

The NMYL Interim National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of Interior and Local Government, an After-Activity Report within fifteen (15) days after the convention has been conducted, with the following prescribed format:

I. Executive Brief;

II. List of Participants;

III. Outputs of Technical Sessions;

- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees collected and Disbursed, if any; and
- VI. Appendices, if any.
