2017 GENERAL ASSEMBLY OF THE LEAGUE OF MUNICIPALITIES OF

THE PHILIPPINES (LMP)

Pursuant to Section 3, Article VI of the Constitution and By-Laws of the League of Municipalities of the Philippines (LMP), the League will be conducting its 2017 General Assembly on March 13-15, 2017 at the *Grand Ballroom, Manila Hotel, City of Manila* with the theme: "Pagkakaisa ng LMP Laban sa Droga, Korapsyon at Kriminalidad."

The theme focuses on creating a deepened dialogue and understanding on the programs of the present administration. The *Mayor's Forum* will also be part of the assembly as an all-important platform to address crucial issues particularly in combating drugs, corruption and criminality. Finally, it will be a venue to set the goals of the new leadership of the LMP as it lays down a roadmap for 2017 and beyond.

In view of the above, and upon the request of Mayor Maria Fe Villar Brondial, National President of the LMP, all Provincial Governors are encouraged to allow their Municipal Mayors to attend the 2017 General Assembly on official business.

The payment of applicable travelling expenses and registration fee, if any, to cover the costs of hotel accommodation, meals and activity materials, per participant, may be authorized in accordance with, and subject to applicable limitations prescribed in COA Circular No. 2012-003 dated October 29, 2012, chargeable against available local funds and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations.

The LMP National President shall submit a Post-Activity Report, through the Director of the Bureau of Local Government Supervision, to the Secretary of Interior and Local Government, within fifteen (15) days after the said activity has been conducted, with the following prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Output of Technical Sessions;
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees Collected and Disbursed; and
- VI. Appendices, if any.

All DILG Regional Directors are hereby directed to cause the widest dissemination of this issuance to the concerned authorities within their respective regions.
