PROVINCE OF SOUTH COTABATO

Sangguniang Kabataan: *Brgy. Lamsugod, Municipality of Surallah*

Barangay Lamsugod urgently disseminated the information about COVID-19 and the government's health safety efforts after a community quarantine was imposed by the provincial government. Together with the barangay officials, the Sangguniang Kabataan hope to prevent the spread of the virus through the IEC campaign. Strict implementation of curfew hours was also conducted to limit people's movement in the community.



Apart from the information campaign, the Sangguniang Kabataan also assisted the barangay officials in preparing and distributing relief goods to the residents.



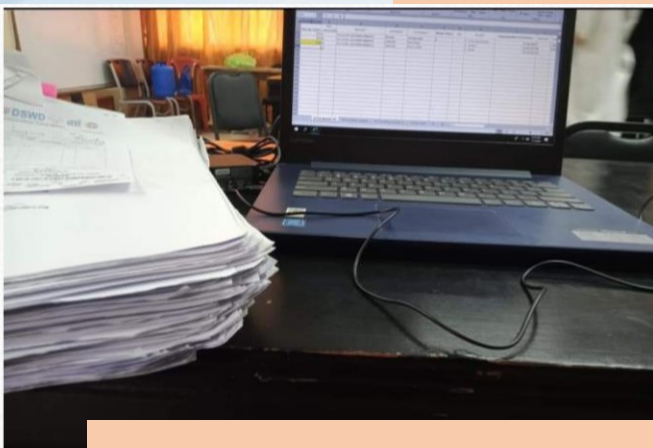

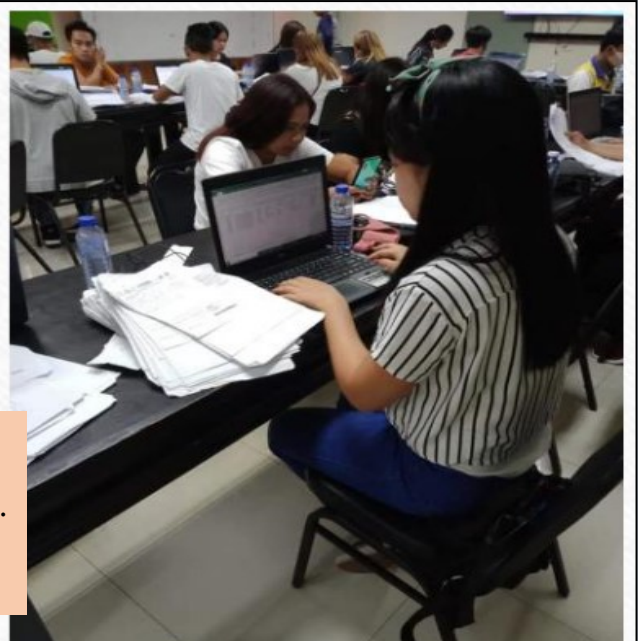
The Sangguniang Kabataan purchased instant noodles, sourced from the SK budget to augment the relief goods prepared by the barangay officials.

SK officials assisted in quarantine checkpoints and help in disinfecting vehicles.



Initiated Information Education Campaign (IEC) or Recorida with regards to COVID-19.



Provided relief assistance to residents of the barangay and snacks for frontline workers.



Assisted the Local Government of Surallah in repacking the relief goods for all the town's constituents.



Assisted in barricading streets within the barangay as local officials implement quarantine protocols.

Sangguniang Kabataan: Brgy. Canahay, Municipality of Surallah

As response to the on-going COVID-19 crisis, the Sangguniang Kabataan of Canahay assisted their barangay and municipal officials in repacking and distributing relief goods to the barangay constituents; provided food packs and snacks to the barangay frontline workers, and assisted in the implementation of security checkpoints.

The Sangguniang Kabataan of Duengas assisted in the packing and distribution of relief goods, enrolment of target beneficiaries under the National Government's SAP, and distribution of quarantine passes to every household.

Assisted in the repacking and distribution of relief goods and health kits to barangay constituents, initiated a feeding program for the poor families in the community, and assisted barangay officials in SAP encoding.

Sangguniang Kabataan: Brgy. Lambontong, Municipality of Surallah

Republic Act No. 11469 or the Bayanihan Heal as One Act was enacted after declaration of National Emergency in the country due to COVID-19. This mandated all government agencies and local government units to have a unified and cohesive response to prevent or contain the virus.

As a response to this call, the Sangguniang Kabataan of Barangay Lambontong, led by Hon. Rey L. Narce Jr., rendered their service and assisted their constituents and frontline workers.



The SK utilized their funds to purchase personal protective equipment (PPEs) such as washable facemasks and face shields for frontline workers. They also assisted in the preparation, encoding, validation, and releasing of financial assistance under the National Government's Social Amelioration Program (SAP).

The Sangguniang Kabataan also shared their little amount of help by sponsoring the meals and snacks of BPATs who are in the frontline, and conducting checkpoints along the barangay borders. They also offered their time to conduct house to house distribution of relief packs from the Local Government Units of Surallah and South Cotabato.

They also assisted in the organization of the outreach program led by a private individual, Mrs. Arlene C. Guerero, and in the issuance of contact tracing IDs as mandated by the Provincial Government of South Cotabato.

The Sangguniang Kabataan of Barangay Danlag prepared IEC materials about COVID-19 and the government's health care protocols, to prevent the spread of the virus. They also assisted the barangay officials in the distribution of almost 3, 000 relief goods to identified beneficiaries.

Sangguniang Kabataan: *Brgy. San Isidro, Municipality of Tampakan*

Together with the Barangay Tanods, the Sangguniang Kabataan of San Isidro strictly imposed the barangay's curfew hours to limit people's movements. Furthermore, they also assisted barangay officials and frontliners in reminding the public of the minimum health safety requirements of the government and in preparing relief goods for the constituents.

LEADING COMMUNITY SPIRIT AGAINST PANDEMIC 2019



As response to the national government's call to be "innovative" in the fight against COVID-19, the SK and local officials conducted weekly disinfection of roads.

The town youth leaders, together with the barangay officials and staff, Local Government Unit of Tampakan, and youth volunteers pooled together to provide assistance to the residents of Barangay Sta. Cruz this time of pandemic.

The barangay initiated a backyard garden for the community to ensure that the residents will have sufficient supply of food.



Youth volunteers and barangay officials worked together in repacking relief goods for the barangay's residents, especially those whose jobs were greatly affected by the pandemic. Household surveys were conducted prior to the distribution to identify the beneficiaries. Information campaign were also conducted by the youth volunteers and Barangay Health Workers.

Sangguniang Kabataan!

In response to the growing concern over the spread of the 2019 coronavirus disease (COVID-19), and in consonance to the Local Government’s MC 2020-018 and DILG MC 2020-023 on the Guide on Action Against 2019 Novel Coronavirus Respiratory Disease, the Sangguniang Kabataan

and the Local Government Unit of Barangay Liberty intensified its information education and communication campaign against COVID-19 to ensure people’s welfare and public health this time of pandemic. Punong Barangay Noli S. Jalagat issued an Execu-

tive Order creating the Barangay Health Emergency Team (BHERT) who will address the barangay’s growing concern over COVID-19. Included in the said membership is the Barangay’s SK Chairman, Renmar Labor.

Following are the activities initiated by the team :

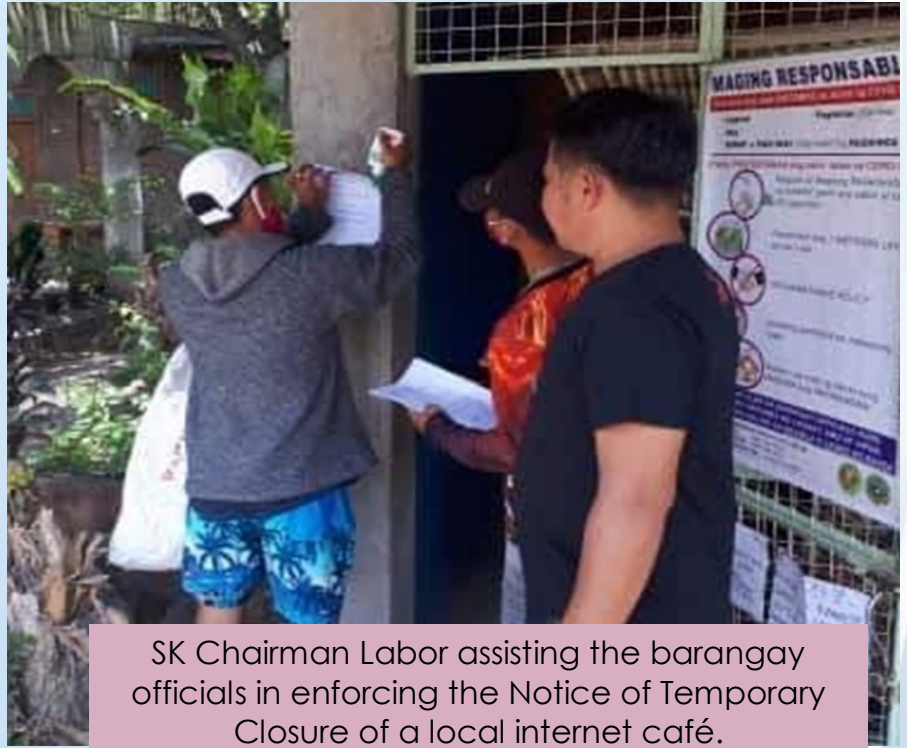


Installation of checkpoints at the barangay’s entry points to monitor and identify all persons entering the barangay, subjecting them to inspections while observing the health protocols.



Distribution of the quarantine passes and contact tracing IDs as mandated by the Provincial Government. The Sangguniang Kabataan mobilized the Purok Youth Organizations for faster distribution of the passes and IDs.

To avoid the transmission of COVID-19, all **establishments were mandated to observe strict health protocols and follow precautionary measures** like establishing handwash areas, wearing of face masks, and social distancing.

Mobilization of Purok -based Youth Organizations to plant corn and vegetables in every purok as a proactive measure to ensure sufficient food supply in the barangay.

Lastly, the SK **assisted in distributing the allocated relief goods** to all residents of Barangay Liberty and in **encoding of SAC forms** of identified beneficiaries of the national government's financial subsidy program.

Sangguniang Kabataan: Brgy. Kipalbig, Municipality of Tampakan

SK MAAASAHAN SAAN MAN

This program focused on providing relief goods to the affected families when the Enhanced Community Quarantine started.

Looking at the employment status of the residents in the barangay, it shows that majority of the constituents merely depend on daily wage jobs which make it difficult for them to prepare

and save for the future needs of their families. Some of them won't even be able to provide for their families' next day meals.

The Sangguniang Kabataan officials foresee that if this pandemic will continue, it will further affect the livelihood of the constituents, cases of theft might increase in the community., and other social issues that may arise.

To address this concern, the SK partnered with the Barangay Health Workers to determine the number of families

that need relief goods. The SK also passed Resolution No. 3 Series of 2020 "Resolution Declaring Sangguniang Kabataan Fund: (1) Socio-Cultural & Tourism – Barangay Anniversary (150,000.00); (2) Support to Mutya ng Tampakan (20,000.00); and (3) SK Election (30,000.00) as Savings Covering C.Y 2020 Amounting to Two Hundred Thousand Pesos (200,000.00) which are no longer viable for implementation with the advent of COVID 19 and the postponement of SK Elections". The said funds were used to purchase sacks of rice for relief distribution.

As a result, The SK was able





to purchase 100 sacks of rice, which were divided into 5 kilos per pack to cater the 1,200 families identified by the BHWs that need support. Purok presidents, youth volunteers and BHWs assisted in distributing the said relief goods to the beneficiaries.



The SK also partnered with the International Christian Organization, Feed my Starving Children, through Kipalbig Alliance Church, that donated 30 boxes of Manna Pack to families with three and more children.

The SK also assisted in guarding border checkpoints in the morning so that members of the Barangay Peacekeeping Action Team could take their rest.

SK TABLU AGAINST COVID-19

The Sangguniang Kabataan, as a part the Local government Unit, prioritizes the welfare of the youth especially this time of pandemic.

As support to local officials, the SK initiated an Information Education and Communication

(IEC) Campaign on COVID-19, health protocols, and on various policies of the government. They also served as additional human resource in the preparation and distribution of food packs for the residents.

The SK hopes that through

the IEC, residents will be informed about the threats of the disease and the guidelines set by the government to prevent its spread in the country. Meanwhile, the distribution of relief goods is the answer of the local government to help mitigate the economic impact to families who lost their jobs due to COVID-19.

BATANG KASANGGAYOLA

A Movement of SK Gayola with the Barangay Council to fight against COVID-19

This year, COVID-19 was one of the major surprises that shocked the world. It brought about countless problems and the fight isn't yet over. With these problems and threats, the SK

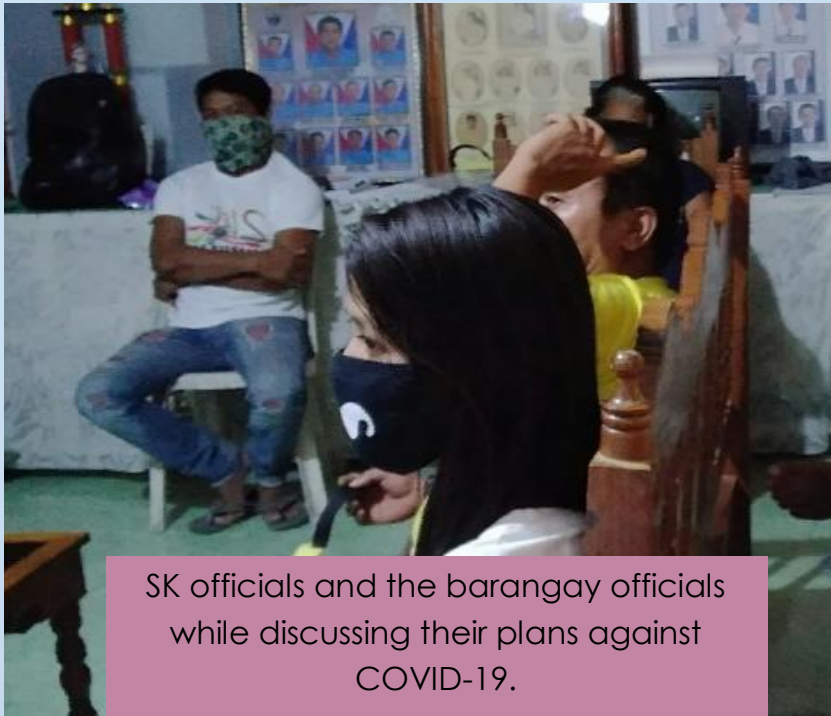
council of Gayola stood and faced their duty to help and protect their people, especially the youth.

In line with these, Batang

KasangGayola was formed which aims to provide assistance to the barangay council in terms of manpower to carry out relief operations, provide assistance in disinfection and border control, and provide hygiene kits and basic goods to the youth of Barangay Gayola.

First, they planned all needed actions together with the barangay council. To maintain safety within the borders, the SK council worked together with the BPATs and BHWs in disinfecting vehicles and sanitizing people coming in of the barangay. They also ensured that the minimum health protocols required by the government, such as wearing of face mask and no back-riding policy, among others, are strictly implemented.

They also they took part in the barangay's repacking and distribution of relief goods. Furthermore, they re-aligned their SK budget to augment the COVID-19 funds of the barangay. At least Php 40, 000.00 was utilized to purchase hygiene kits such as anti-bacterial soaps, detergent bars, and

other basic food needs such as sugar and instant coffee. On April 29, 2020 they were able to distribute basic hygiene kits to 450 identified youth and their families. The initiative was warmly received by the beneficiaries. At least 600 hotdog barbecues were also provided to children in the barangay.

Barangay Gayola remains COVID-19 free up until today.

To The ReSKyu

[This project focuses on the four aspects of Development such as Health, Education, Governance, and Active Participation]

ReSKyu is a project that required the SKs from the 40 barangays to provide fund support for the purchase of various health and sanitation kits for the municipality. These include foot baths, handwashing needs, and alcohols, among others.

This financial support is also to augment the town's funds for the purchase of rice to be distributed to its residents.

Apart from the financial support, the SK also served as additional manpower for the conduct of thermal scanning, contact tracing, implementation of border checkpoints, and encoding of SAC forms.



ONE CAN'T, MANY CAN PROJECT

The To the ReSKyu Project team initiated a livelihood program by encouraging the youth to make broomsticks which were later bought at 5 pesos higher than the market price. Collected products were donated to the different public schools across Pigcawayan.
