

Frequently Asked Questions (FAQs):

Who are the beneficiaries of the DILG-administered Package of Assistance?

- All Former Rebels (FRs) who were members of the New People's Army and Militia ng Bayan who surfaced April 3, 2018 onwards.
- All Former Violent Extremists (FVEs) who were members of the Abu Sayyaf Group, Maute Group, Dawlah Islamiya, Bangsamoro Islamic Freedom Fighter, Turaife Group, and other violent extremist groups who surfaced April 3, 2018 onwards.

What is JAPIC Certification and its bases?

In the issuance of JAPIC Certificate, the Periodic Status Report of Threat Group (PSR-TG) list for 2018 shall be the basis in the determination of the eligibility of FRs and FVEs who will be enrolled in the DILG-administered Package of Assistance under the ECLIP. If the FR or FVE is not listed in the 2018 PSR-TG list, only those who can be conclusively proven FRs and FVEs on or before December 31, 2018, shall be considered for enrolment in the program upon further assessment and decision of the concerned local ECLIP Committee.

"The program was renamed National Program for Unification and Development in 1994 and was expanded in the year 2000. The OPAPP in 2007-2010 facilitated the Social Integration Program in 2007-2010. It was later called Comprehensive Local Integration Program. The program was later transfered to DILG through DILG-OPAPP JMC No. 2014-01. It was further called ECLIP and presently the entire program is referred to as ECLIP and Amnesty Program under the Executive Order 70."

WHAT IS ELCIP?

a comprehensive, integrated, and community-based national program that is locally implemented to address the legal status and security of former rebels, as well as their economic, social and psychological rehabilitation needs.

On December 04, 2018, President Rodrigo Roa Duterte signed the **Executive Order No. 70** institutionalizing the "Whole-of-Nation Approach" to address the root cause of insurgencies, internal disturbances and tensions, and other armed conflicts and threats by prioritizing and harmonizing the delivery of basic services and social development packages by the government, facilitating societal inclusivity, and ensuring active participation of all sectors of the society in the pursuit of the country's peace agenda.

Php 21, 000 (For Receiving Unit to Regular NPA, MB, and FVEs)

Halfway House



Php 5, 000, 000 fund for the construction of the halfway house for the Former Rebeles or Former Violent Extremist.

WHAT ARE THE DOCUMENTARY REQUIREMENTS IN AVAILING ASSISTANCE UNDER THE PROGRAM?

For Immediate and/or Livelihood Assistance:

- JAPIC Certification; and
- ECLIP Enrolment Form.

For Firearms Remuneration:

- JAPIC Certification;
- ECLIP Enrolment Form;
- Property Turn-In Slip (PTIS);
- Technical Inspection Report (TIR); and
- Cost Valuation Certificate.

For Reintegration Assistance:

- JAPIC Certification:
- ECLIP Enrolment Form; and
- Official Receipt/s.

For the Construction of Halfway House:

- Written request from the LGU/ Receiving Unit;
- Proof of Land Ownership;
- Program of Works;
- Local Sanggunian Resolution (LGU) granting authority to the LCE/Authority from the Principal (Receiving Unit); and
- Memorandum of Agreement (MOA) between DILG and the LGU.
