PERFORMANCE CHALLENGE FUND (PCF)

Summary of PCF projects and financial status:



The Performance Challenge Fund (PCF) was first implemented in 2010 with the goal of assisting the national government to rationalize intergovernmental transfers to LGUs towards improving local performance in governance and delivery, and help decrease the LGUs' dependency in their share from the Internal Revenue Allotment (IRA) as they carry out their devolved functions, especially those classified under the 4th to 6th class municipalities. Since 2018, PCF was given as incentive to LGUs that passed the Seal of Good Local Governance (SGLG) – an award and recognition-based program of DILG, which aims to improve LGUs' performance in 10 key governance areas.

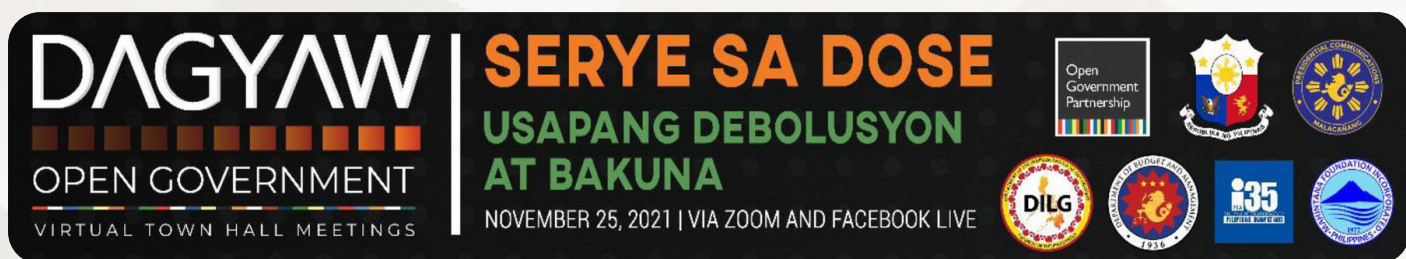
In 2019, five of Region XII's LGUs were granted with PCF funds, with a total amount of Php 12,700,000.00,

as incentive for passing the SGLG assessment during the said year. These LGUs included Kidapawan City and Midsayap of Cotabato Province; Lambayong and Lutayan of Sultan Kudarat; and Surallah of South Cotabato.

As of December 31, 2021, **five (5) of the 2019-funded PCF subprojects** were completed. From 2011 to 2019, Region XII recorded a total of **153 PCF subprojects** with a total worth of **Php 307,200,000**. The projects that were implemented are in support to the attainment of the Millennium Development Goals, Disaster Risk Reduction Management, Local Economic Development, Ecological Solid Waste Management, and Promoting Transparency and Accountability.

Region XII Dagyaw Townhall Meeting talks about Devolution and Vaccination conducted on November 25, 2021, with 231 zoom virtual attendees.

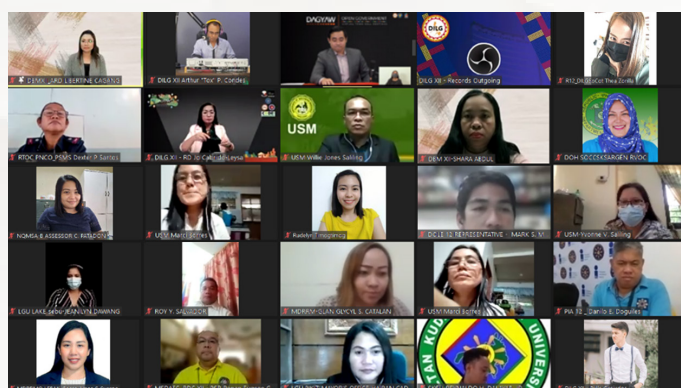
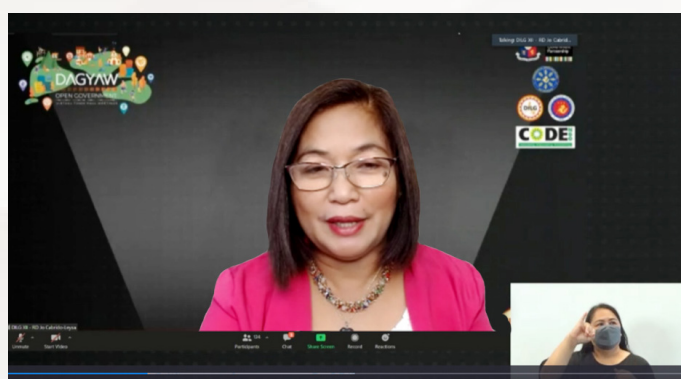

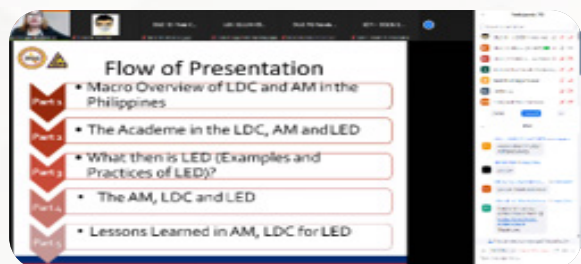

The Department of the Interior and Local Government Rehiyon Dose recognized the Most Outstanding Sangguniang Kabataan for the first time in the SOCCSKSARGEN Region last November 14, 2021 during the Regional Awarding Ceremony of the Governance Exemplars for Meaningful Service for SK (GEMS for SK).

The ceremony was conducted at The Farm at Carpenter Hill, Koronadal City, South Cotabato, attended by the Members of the Regional Management Committee headed by DILG Dose Regional Director Josephine Cabrido- Leysa, CESO III, SK Regional Federation Officers, C/MLGOOs, and other partners in the Monitoring and Evaluation Teams.

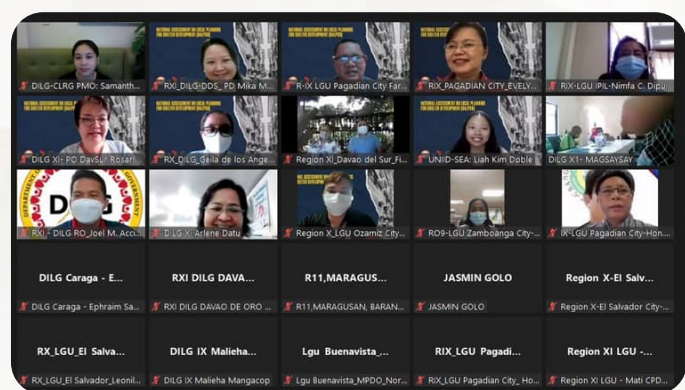

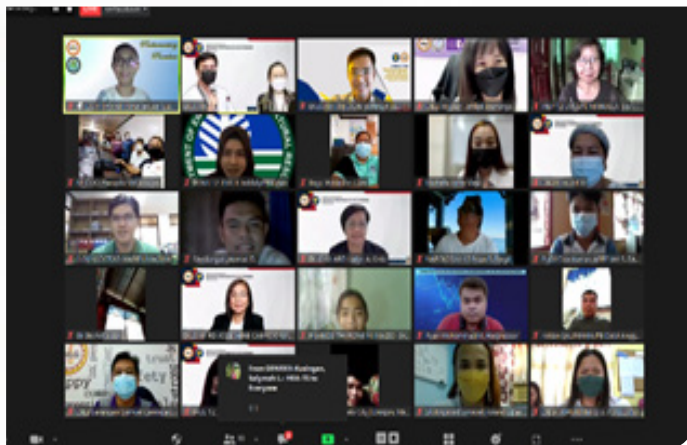

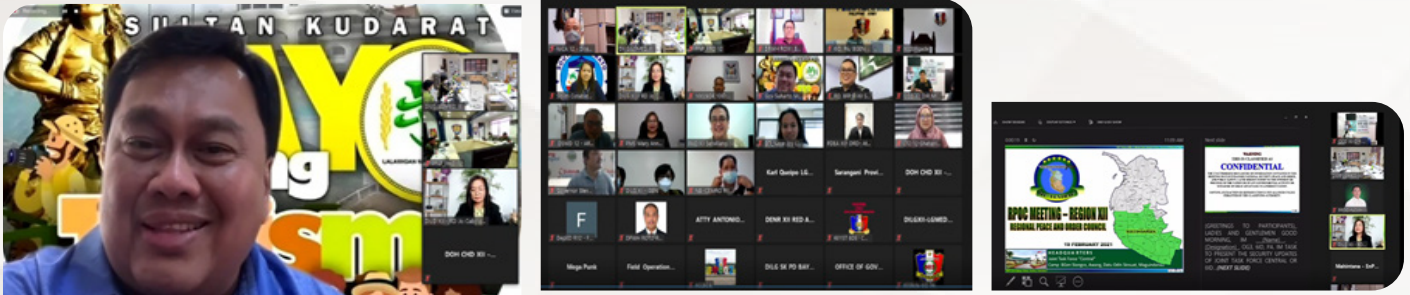

With the Province or Highly Urbanized City (P/HUC) as the focal authority, the program responds to the circumstances, needs and concerns of former rebels in a sustainable and consistent manner.

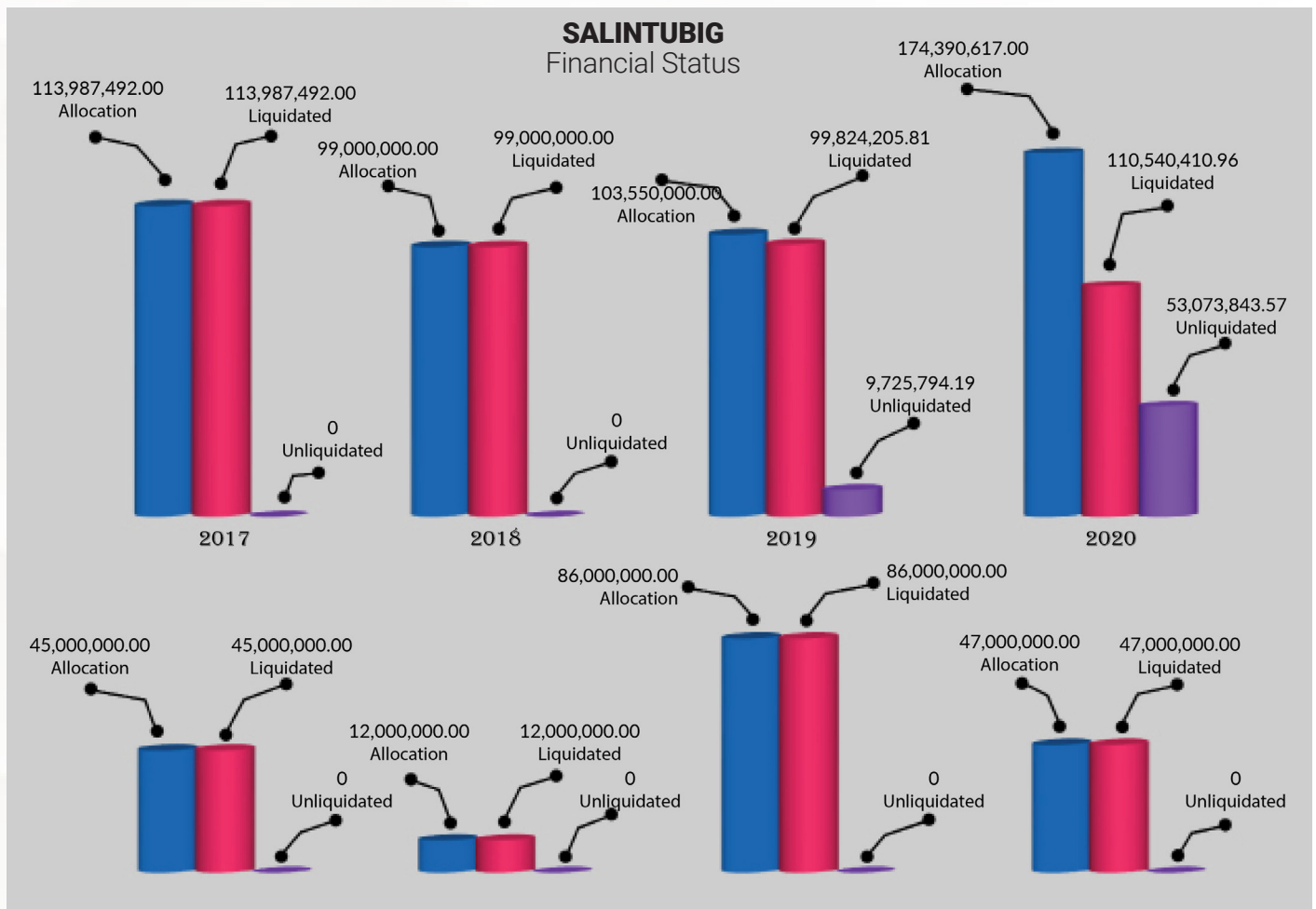
SALINTUBIG PROGRAM

Sagana at Ligtas na Tubig sa Lahat (Salintubig) Projects

Committed to provide potable water to poor and waterless communities, the national government implemented the SALINTUBIG program under the Local Government Support Fund (LGSF). Sagana at Ligtas na tubig sa Lahat, or SALINTUBIG, aims to provide water systems to waterless communities through financial assistance, and improve the capacities of Local Government Units and their water service providers in managing water supply systems in a sustainable manner through capacity development activities.

In Region XII, the program has immensely helped LGUs provide potable water to its waterless communities – one that is accessible to almost every household – and minimizing the risks of water-borne diseases.

As of December 31, 2021, Region XII was able to complete 36 2020-funded water supply system projects, providing far-flung, waterless communities in various LGUs in the Region with safe and accessible water. The accomplishment is in addition to the existing 136 completed potable water projects in the region from 2012 to 2019. To date, 5 water projects funded in 2020 are on-going.



ASSISTANCE TO MUNICIPALITIES (AM) PROGRAM

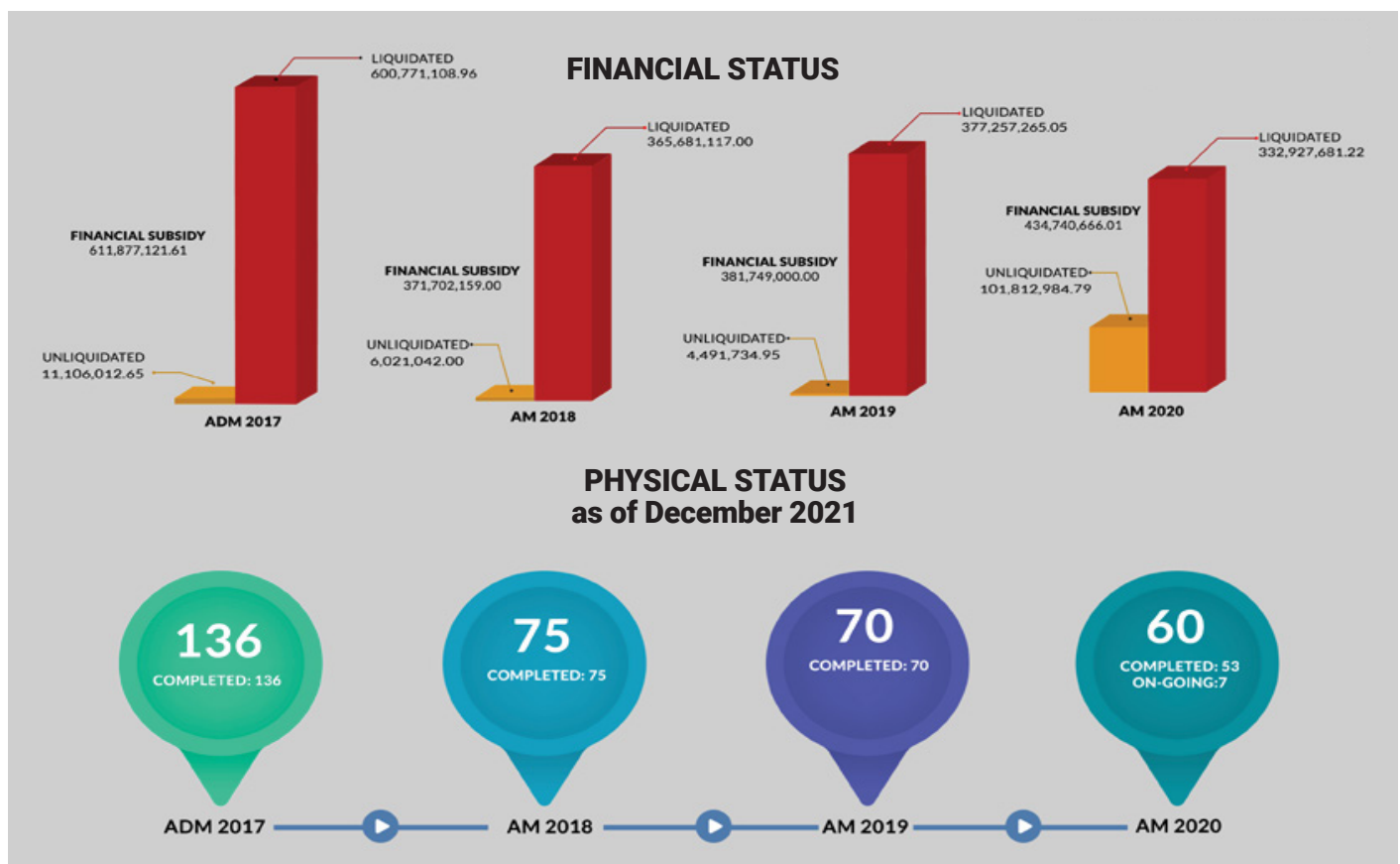
As Municipal Local Government Units face the rising public expectations on public service delivery and challenges in the exercise of devolved service delivery functions, the National Government offered its Assistance to Municipalities or AM Program under the Local Government Support Fund (LGSF).

As part of the LGSF, AM seeks to equitably assist all municipalities in the delivery of basic services through financial subsidy to implement their priority programs and projects. It funds various projects of the municipal LGUs culled out from their respective Local Development Investment Plans (LDIPs).

As of December 31, 2021, Region XII was able to complete 59 out of its 60 AM projects funded in 2020, while 1 project in Sultan Kudarat is still on-going.

The mayor is joined by Vice Mayor Timee Joy Torres-Gonzales and Assistant District Engineer Benedicto Amido of the DPWH 2nd District Office.

The two- storey building features a spacious tiled ground floor for the fish and meat stalls while the 2nd floor has rentable spaces. At least 43,425 residents of the town are expected to benefit from the project.

DILG XII Regional Director Josephine Cabrido-Leysa personally turned-over a long list of DILG-funded projects worth more than P34 million to LGU of Banisilan in Cotabato Province on March 19. Director Leysa congratulated the LGU for the successful implementation of the said projects despite its location and limitations. Banisilan is roughly two and a half hours away from Kidapawan City, the capital town of Cotabato Province and more or less four hours away from Koronadal City, SOCCSKSARGEN's Regional Seat. Thankfully, most of the highway linking Carmen and Banisilan are well-paved, except for a few stretches in the mountain passes.

The director turned-over one evacuation center, various evacuation facilities and four local access road projects to LGU Banisilan in a simple ceremony held in one of the completed roads in Brgy. Poblacion 1, a few blocks away from the public market and the commercial center. In her message, Director Leysa challenged



all the municipal and local officials in attendance to "implement the projects the right way and take care of these projects which were funded by the government through the DILG and to implement future projects accordingly."

IMPROVED LGU COMPETITIVENESS AND EASE OF DOING BUSINESS (EODB)

Promotion of e-BPLS

A webinar entitled, 'Online Rollout on the Promotion of electronic-Business Permits and Licensing System (eBPLS) for LGUs' was conducted last July 6, 2021, from 08:00 AM to 04:30 PM via Zoom, to promote the use of electronic permitting and licensing systems, and specifically to motivate LGUs to implement the electronic Business One-Stop Shop (eBOSS), as described in Section 11 of the EODB-EGSB Act of 2018.



Rollout on the Repeal of Policies for LGUs



Attended by fourteen (14) LGUs across Region 12 on June 10-11, 2021, at The Farm, Carpenter Hill, Koronadal City, South Cotabato, this activity aims to provide LGUs the knowledge for reforming their regulatory practices in harmony with the Ease Of Doing Business and Efficient Government Service Delivery Act (RA 11032), adjusting to the 'new normal' imposed by the COVID-19 pandemic with respect to their permits and licensing activities, and finally allowing LGUs to simplify their regulatory agenda via the use of DILG's RR4LGUsIS, a repository system designed to allow LGUs to record their regulatory policies as available, amended, repealed, or even consolidated, as well as comparing and cross-referencing other policies from other LGUs.

Streamlining Building Permits and Certificates of Occupancy cum Integration of Barangay Clearance

In support to the continuing improvement of competitiveness and ease-of-doing business in the Philippines in line with the President Duterte's 10-point Socio-Economic Agenda and as outlined in RA 11032, DILG XII conducted a blended training on STREAMLINING BUILDING PERMITS AND CERTIFICATES OF OCCUPANCY (BPCO) and on the INTEGRATION OF BARANGAY CLEARANCE IN THE LGU PERMITTING PROCESSES at the Viajera Dine and Café last August 18-19, 2021.



This activity was attended by 45 participants who showed up at the venue, along with 98 attendees who joined via Zoom, all coming from fifteen (15) 2nd and 3rd class LGUs of Region XII. They went through reorientation and training on the operationalization of the following:

1. DILG-DPWH-DICT-DTI Joint Memorandum Circular (JMC) 2018-01: Guidelines in Streamlining the Processes for the Issuance of Building Permits and Certificates of Occupancy (BPCO),
2. DPWH-NBCDO Memorandum Circular NO. 01-2020: Adoption of Unified Application and
3. Revised Permit Form for Building Permit and Certificate of Occupancy, as well as ARTA-DILG-DTI-DICT Joint Memorandum Circular NO. 2021-01: Guidelines for Processing Business Permits, Related Clearances, and Licenses in All Cities and Municipalities.

CBMS Regional Forum

In the implementation of RA 11315, also known as the Community-Based Monitoring System Act, DILG XII conducted a CBMS Regional Forum on November 5, 2021, at Greenstate Convention Center in Koronadal City, with participants from all P/C/MPDCs of LGUs within Region XII attending physically.



Partners from PSA, DICT, and DILG BLGD were present in the activity, each providing valuable inputs. The morning session of the forum outlined the status of CBMS, salient features of RA 11315 as well as its IRR, and finally, the roles of key stakeholders in the 2022 National Rollout of the CBMS led by PSA.

In the afternoon there were discussions on the critical CBMS tools. The experiences of LGUs previously implementing CBMS, and an open forum that outlined key questions to be discussed in the National CBMS Forum capped the activity.



Balik Probinsya 2 Program



President Duterte's EO 144, series of 2020, provides for the creation of the 'Balik Probinsya, Bagong Pag-asa (BP2)' Program, which seeks to improve economic opportunities for countryside development and institutionalizing support thereof.

As part of the implementation of this JMC, DILG XII led the conduct of a three-day face-to-face training workshop 'Roll-out Training on Local Economic Development and Workforce Development Program (Strengthening Initiatives for Balanced Growth and Opportunities at the Localities (SIBOL))' at Viajera Hotel Dine and Café, Koronadal City last December 1-3, 2021.

Partners from DILG-BLGD, DOLE XII, TESDA RO XII, and DTI RO XII assisted six LGUs across the region in the preparation of their respective Draft Workforce Development and LGU Action Plan to assist them in implementing the SIBOL program, as well as capacitating LGUs in local economic development, planning, and best practices on public-private partnership on LED.



LED and Workforce Development (SIBOL)

As part of continued effort in the implementation of DILG Memorandum Circular 2018-214, entitled 'Reengineering of LGU Systems and Procedures in Compliance to EODB-EGSD Act of 2018', DILG XII conducted the Training on Guidelines on the Streamlining of LGU Systems and Procedures on Business and Non Business-Related Services for Cities and Municipalities on December 16-17, 2021, held at Greenstate Convention Center, Koronadal City, South Cotabato.



This face-to-face training workshop was attended by the respective BPOs, Municipal Treasurers, LEIPOs, and various Sanggunian Members of ten different LGUs in Region 12 alongside DILG EODB focal persons. It aims to standardize the processing of business and non-business-related transactions of LGUs, as well as provide guidelines on the streamlining of relevant processes in compliance with existing laws.



Representatives from DILG-BLGD and CSC, alongside DILG XII personnel, provided valuable information during the seminar. Key points from the workshop include a lecture on the LGUs clientele with respect to their experiences in processes rendered by the LGU, a simplification of processes as part of digital transformation, and a discussion on the DILG-ARTA Joint Memorandum Circular 2021-01.



Updating of Local Revenue Code

5 Local Government Units in Region XII trained on the "Updating of the Local Revenue Code", these LGUs are Palimbang, Banga, Maasim, Esperanza, ang Magpet, with their Municipal Treasurers, Business Permit and Licensing Officers, Budget Officers, Zoning Officers, Legal Officers, and 2 Sangguniang Members, held at Paraiso Verde Hotel last October 21-22, 2021.

This activity was spearheaded by the Local Government Capability Development Division (LGCCDD) of the DILG XII. All invited participants attended the activity physically following strict adherence to minimum health protocol against COVID-19 Virus.

CONDITIONAL MATCHING GRANT TO PROVINCES (CMGP)

The Conditional Matching Grant to Provinces (CMGP) for Road and Bridge Upgrading, Rehabilitation and Improvement, is a governance reform partnership program between the Department of the Interior and Local Government and Department of Budget and Management (DBM) for Provincial Local Government Units through infrastructure support. It aims to partly address the poor state of provincial roads across the country, and improve the competency of Provincial Local Government Units in Local Road Management and Public Financial Management through governance reforms. CMGP is formerly known as

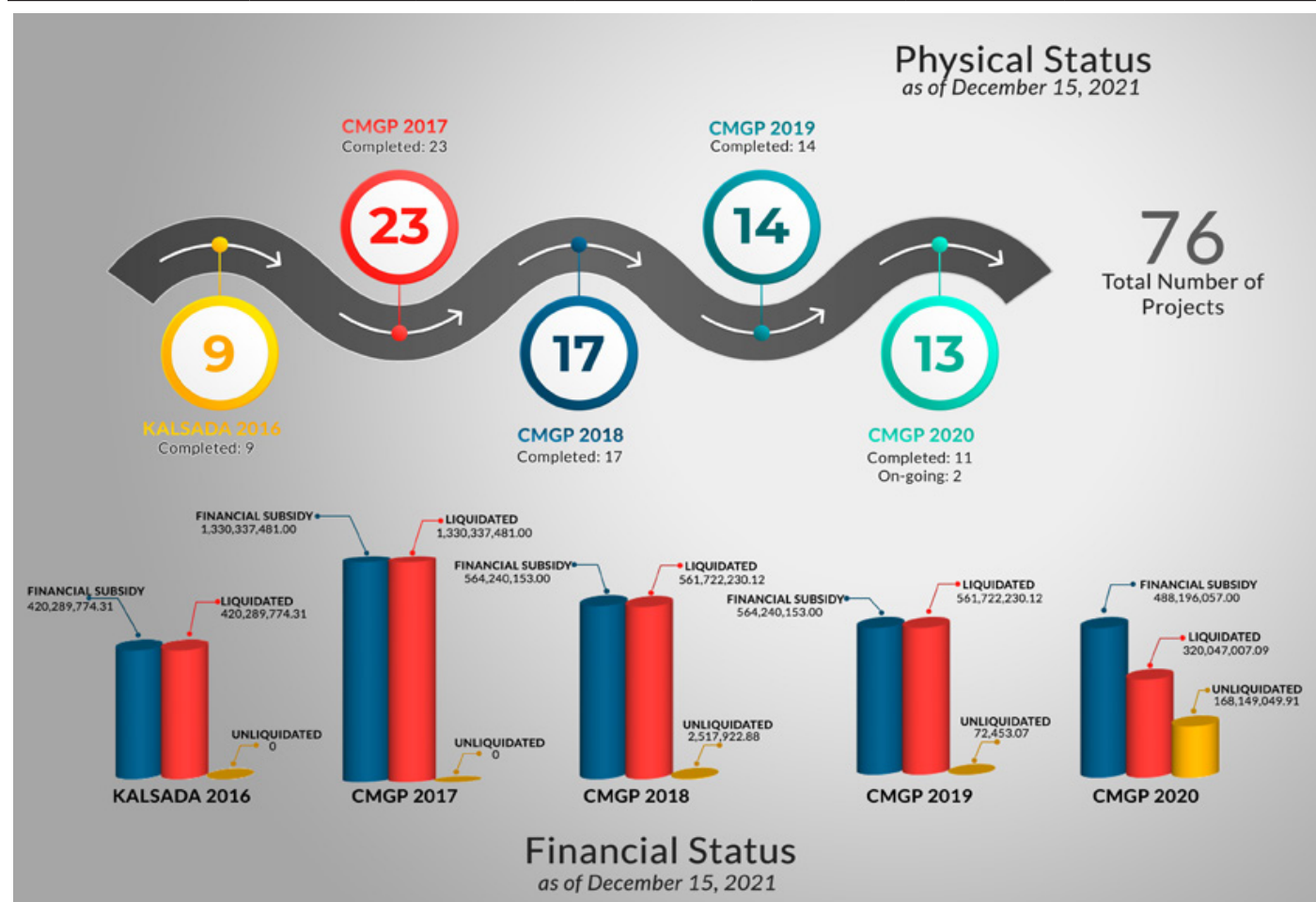
Konkreto at Ayos na Lansangan ang Daan tungo sa Pangkalahatang Kaunlaran (KALSADA) Program.

In Region XII, CMGP has helped provincial governments in improving community and road connectivity, particularly in far-flung sitios and farms, providing better circulation of people and goods and uplifting people's socio-economic status.

As of December 31, 2021, the Region was able to complete 11 out of 13 2020-funded CMGP projects with remaining 2 projects that are on-going.

The much-awaited commencement of the SBDP projects for Region XII kick-started with series of groundbreaking activities held in recipient barangays of Farm-To-Market Road Concreting Projects of Cotabato Province last September 2021.

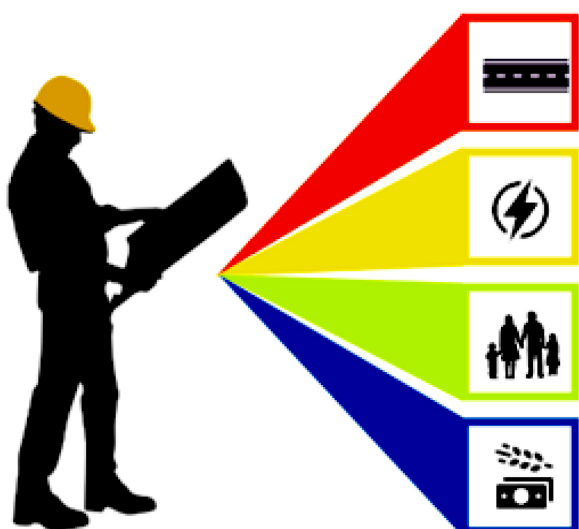
Brgy. Luayon (Makilala), Brgy. Batang (Tulunan), Brgy. Datu Ladayon (Arakan), Brgy. La Esperanza (President Roxas), New Cebu (President Roxas), Don Panaca (Magpet), Bantac (Magpet) were the first seven (7) barangays to proceed the implementation after rigid preparations and reviews of technical and documentary requirements.

The remaining projects under the LGSF-SBDP Program for all the provinces in Region XII were also arranged to proceed by the last quarter of 2021.

As the program prioritizes the cleared barangays from insurgency, recipient communities shared that through this initiative, they can now really feel the presence and assistance of the government.

SBDP strategically took into account the involvement of the community, from residents to barangay officials, in the proposal of the most essential projects they believed will benefit them the most.

The region is set to deliver a **total of two hundred six (206) projects under the LGSF-SBDP**. This is comprised of infrastructure, social services, and livelihood projects to be implemented in **Cotabato Province (57), Kidapawan City (44), Sultan Kudarat (62), Sarangani Province (41), and South Cotabato (2)**.

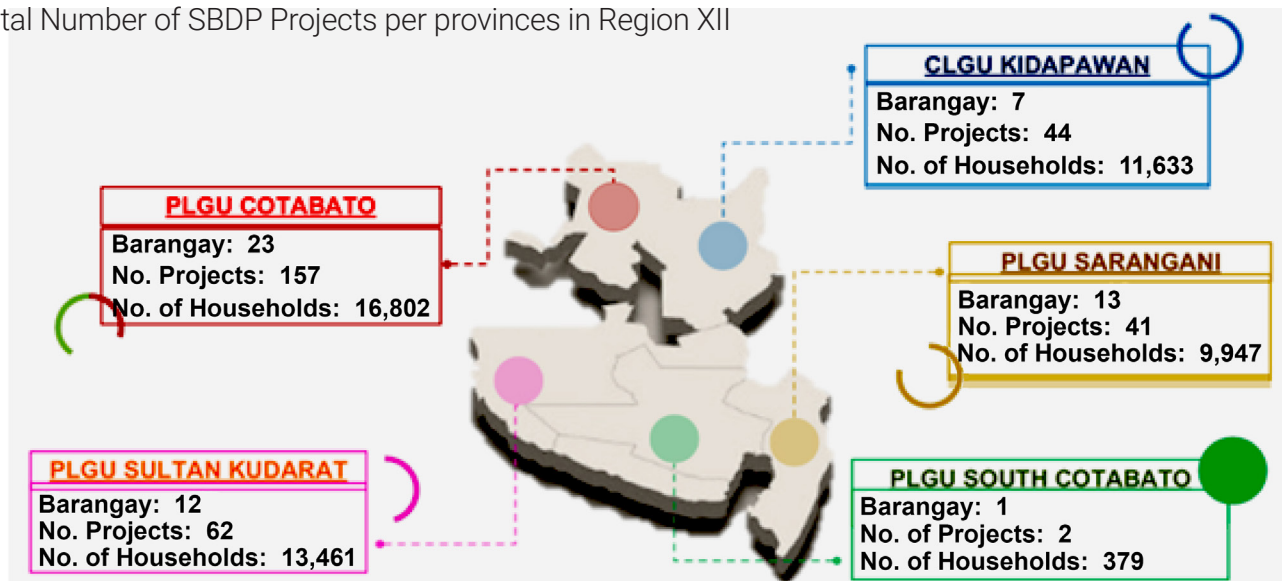

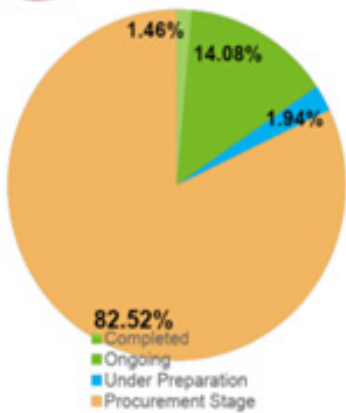

Each of them had to go through the scrutiny of Ms. Liza G. Rosal from Certification International Philippines, Inc.

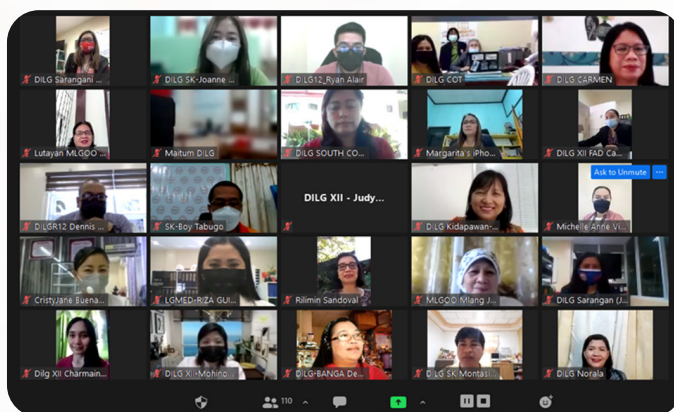
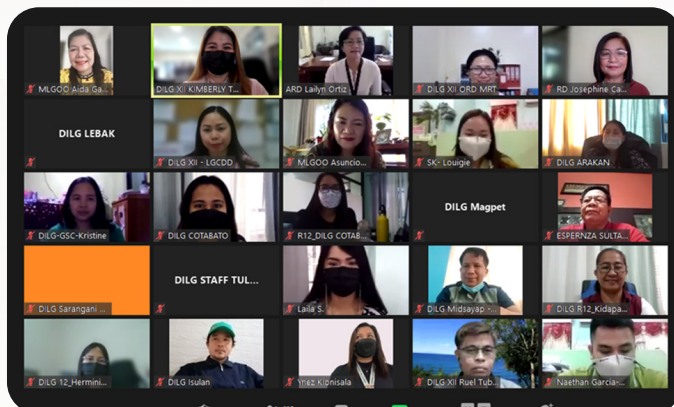
Maintaining DILG XII’s ISO 9001:2015 certification is a testament to its unceasing commitment to continually improve its systems and processes to serve its clients better.

DILG XII has launched its National Quality Management System last March 2021 pursuant to Executive Order No. 605 requiring all agencies of the Executive Branch to adopt the ISO 9001 Quality Management Systems and to comply with the FY 2020 Performance-based Bonus (PBB) Guidelines per AO 25 Memorandum Circular No. 2020-01.

The Memorandum Circular directs all agencies to secure an agency-wide QMS certification for the standardized frontline processes, to jump start its preparations, series of focus group discussions and workshops were conducted to harmonize and finalize Region XII's Quality Manual, System Procedures and Quality Processes. As a support to achieve the said objective, the Regional Top Management conducted its own Regional Orientation last June 24, 2021.
