ACCOUNTABLE, TRANSPARENT, PARTICIPATIVE, AND EFFECTIVE LOCAL GOVERNANCE

Full Disclosure Policy (FDP)

The PROVINCE OF COTABATO (with 19 Provincial/ City/ Municipal LGUs) conferred 17 LGUs for CY 2023 Good Financial Housekeeping (GFH).

Pursuant to the Department of Interior and Local Government (DILG) Memorandum Circular No. 2014-39, the GFH is conferred to an LGU that exhibits compliance with accounting and auditing standards, rules, regulations, i.e. most recent available COA Audit Opinion is either the unqualified or qualified as well as compliance with the DILG's Full Disclosure Policy where all required financial documents are posted in three conspicuous places and the FDP portal for the second to fourth quarters of CY 2022 and the first quarter of CY 2023.


GFH (previously known as the Seal of Good Financial Housekeeping) is a program of the Department that supports the promotion of transparent and accountable local government units.



Meanwhile, 100% of barangays in Cotabato Province are compliant with the Barangay Full Disclosure Policy for CY 2023. This includes the posting of 8 financial documents in 3 conspicuous places within their respective barangays which were validated by the City/Municipal Local Government Officers (C/MLGOO) assigned in the area.

In addition, **100% of Sangguniang Kabataan** were compliant with FDP pursuant to DILG MC 2023-068 issued last April 28, 2023. A total of 7 financial documents were posted in 3 conspicuous places validated by the C/MLGOOs.



On the other hand, last December 7, 2023, the DILG Regional Office capacitated the LGU FDP Focal, C/MLGOOs, and Provincial Focal Person on the Full Disclosure Policy which was conducted via Zoom platform. This orientation was a result of the 2023 Seal of Good Local Governance (SGLG) report.

Lastly, the discussion on the latest issuances, portal navigation, and timeline was among the highlights of the said activity.

Seal of Good Local Governance (SGLG)

DILG Cotabato assisted the Provincial Government of Cotabato in a special meeting for the conduct of the prestigious and the most awaited CY 2023 on-site assessment for the SGLG in Amas, Kidapawan City on April 24, 2023.

The provincial SGLG team headed by DILG Outcome Manager (OM) Inecita Kionisala, together with Helen Grace de Justo-Sayon, SGLG Provincial Focal Person, and



Mark L. Biescas SGLG Provincial Alternate Focal Person presented with the heads and representatives of various PLGU offices the 2022 results and the proposed initial indicators for the CY 2023 assessment.



Likewise, on May 10, 2023, the DILG Cotabato conducted an Orientation on the CY 2023 SGLG to its Field Officers and LGU SGLG Focal Person at FCG Hotel and Resort, Binoligan, Kidapawan City.

The activity was conducted to foster a comprehensive understanding of the key indicators, assessment process, and timelines. This orientation proved to be a crucial step in preparing the LGUs for the assessment proper.

Aside from orientation, the **DILG Cotabato also conducted a series of pre-assessment of its 19 LGUs last May 11-24, 2023.**

LGOO V Helen Grace De Justo-Sayon, SGLG Provincial focal person, conducted an on-site visit to the LGUs together with the respective C/MLGOOs and reviewed the LGU documents as one of the strategies of the DILG Cotabato to increase the number of its SGLG passers. The pre-assessment laid a solid foundation for the SGLG assessment, offering valuable insights into the strengths and challenges of the LGUs.



In addition, the SGLG Regional Assessment Team (RAT) of Cotabato Province headed by OM Inecita C. Kionisala, Program Manager Vita V. Gumahad, LGOO V Helen Grace De Justo-Sayon, and CSO Representatives from Ha Uman Association validated the different LGUs of Sultan Kudarat Province on June 20-July 14, 2023 during the cross-assessment on SGLG.

The assessment focused on the 10 core criteria of SGLG, ensuring a holistic understanding of each LGU's governance practices. This is the crucial stage of the SGLG implementation wherein the assessors validated thoroughly the means of verification visa vis the indicators.

After a simultaneous cross-assessment, the SGLG RAT from DILG Cotabato attended the Regional Calibration last July 17-18, 2023, at the Wagi Conference Hall, DILG Regional Office XII.

The SGLG regional calibration serves as a vital quality control mechanism. It plays a fundamental role in the overall assessment process by scrutinizing the accuracy and consistency of assessment scores provided by LGUs.





The City of Kidapawan and Municipality of Pigcawayan conferred with the FY 2023 Seal of Good Local Governance on December 14, 2023, at the Manila Hotel.

This award was given to the LGUs upholding the principles of transparency and accountability in the use of public funds, preparedness for challenges posed by disasters, sensitivity to the



needs of vulnerable and marginalized sectors of society, implementation and sustenance of policies and programs that would strengthen and promote the well-being, healthy lifestyle and safety of the public, investment and employment promotion, and protection of constituents from threats to their lives and property.





It was attended by the concerned Local Chief Executives, C/MLGOOs, and Provincial Director Ali B. Abdullah. The two (2) LGUs received an incentive fund subsidy amounting to 2.3 Million pesos for the City of Kidapawan and 1.8 Million pesos for the Municipality of Pigcawayan in the form of a project.

Meanwhile, the other three (3) Municipalities in Cotabato Province namely: Kabacan, Magpet, and Midsayap were potential passers on CY 2023 SGLG and underwent national validation last September 18-21, 2023.

The National Validation Team (NVT) from DILG Region IX headed by LGOO VII Junefer B. Paquibot with LGOO V John Mark J. Ruiz, scrutinized the documents of the said LGUs.








The DILG Cotabato assisted during the conduct of the Program Implementation Review of SGLG in the Province of Cotabato on October 26, 2023, at the Acacia Hotel, Davao City. It was attended by the department heads, SGLG focal persons, and other agencies.

PD Abdullah ensured its 100% support to the Provincial Government of Cotabato in the attainment of the SGLG award next year.

The table above shows that the top 3 governance areas with the highest number of LGUs compliant were the following: (1) Health Compliance and Responsiveness (100%), (2)Tourism, Heritage Development, Culture, and Arts (89%) and, (3)Sustainable Education and Safety Peace and Order (both 84%).

Meanwhile, there is a need to strengthen the monitoring and provision of technical assistance in terms of Social Protection and Sensitivity (16%), Financial Administration and Sustainability (42%), and Disaster Preparedness (53%) having the lowest compliance among the LGUs in the province.

Further, 100% of the LGUs conducted SGLG Exit Conference and submitted a post-activity report to the Regional office.

Seal of Good Local Governance Incentive Fund (SGLG-IF)

On February 22, 2023, the DILG Cotabato attended the Regional Roll-Out on the Guidelines of SGLG-IF Implementation in Koronadal City. It was attended by the LGUs of Magpet and Kidapawan City, the CY 2022 SGLG passers of Cotabato Province.

SGLG-IF evolved from long-standing flagship program the Performance Challenge Fund (PCF) which serves as performance-based reform program of the DILG that seeks rationalize intergovernmental transfers of the national government to local government and encourage the convergence of local development initiatives with national development agenda and priorities.

The following are the projects chosen by the LGUs for the SGLG-IF grant:

As of December 31, 2023, the two projects were completed and turned over to the LGU. This includes the transfer of accountability and responsibility to the concerned LGUs.





Seal of Good Local Governance Barangay (SGLGB)



On May 8, 2023, the DILG Cotabato attended the Regional Orientation on SGLGB via Zoom. This was attended by the Provincial, City, and Municipal Assessment Teams. The following are the topics discussed during the said orientation (1) 2023 SGLGB Guidelines of Implementation and (2) Criteria of Assessment.

The resumption of the SGLGB assessment is a significant development in the pursuit of good governance and excellence in public service delivery.


Moreover, 460 out of 480 barangays in the Province of Cotabato were assessed under the principle "3+1", (3) Core Areas of Financial Administration and Sustainability, Disaster Preparedness, and Safety, Peace, and Order, and at least one (1) Essential Area of Social Protection and Sensitivity, Business-Friendliness, and Competitiveness, or Environmental Management last July to September 2023.

The result of the said assessment was submitted to the National for review and calibration. Awarding of the seal will be next year, February 2024, based on the calendar of activities of SGLGB.

🔷 Lupong Tagapayama Incentives Award (LTIA)

The DILG Cotabato convenes its LTIA-Provincial Awards Committee (PAC) last January 30, 2023, at Governors Cottage, Amas, Kidapawan City for the CY 2023 LTIA Evaluation. It was attended by the PNP, Ha Uman Association, DILG, Provincial Prosecutor, and Provincial Liga ng mga Barangay.

LGOO V Narciso M. Beceira, Provincial Focal Person, discussed the guidelines, for the conduct of assessment, indicative calendar, technical notes, and processes of reporting among others. Highlighted was the use of a new online LTIA-information system through the DILG intranet which shall be utilized from the city/municipality level to the National level.





In addition, last February 7 - 21, 2023, LTIA-PAC conducted its series of LTIA evaluations in the Province of Cotabato. The following are the 18 barangays assessed:

The LTIA annual search is an that recognizes the outstanding lupong that adequately tagapamayapa demonstrates the ability to judiciously and expeditiously resolve cases referred to them and demonstrate exemplary performance with the commendable contribution in the promotion implementation of the Katarungang Pambarangay in their respective locality.

Furthermore, the LTIA-PAC calibrated the result of the assessment on February 22, 2023, at the Governor's Cottage, Amas, Kidapawan City. Below are the top Five (5) Provincial Winners for 1st to 3rd class municipalities category:

Meanwhile, the Brgy. Ginatilan, Kidapawan City was the entry for the category while the cities Sinkatulan, Makilala for the 1st to 3rd class municipalities category. The two barangays were assessed by the LTIA-Regional Awards Committee (RAC) last April 26, 2023.

The barangays were assessed based on the DILG MC no. 2023-022.





Province top-performing barangays on LTIA during their Kalivungan Festival Awards Day last August 29, 2023, at Provincial Capitol Gymnasium, Amas, Kidapawan City. Aside from a plaque of appreciation, the barangays received a monetary incentive from the Provincial Government of Cotabato.

Moreover, the DILG Cotabato served as a resource person during the conduct of Federation Capacity Enhancement Training on Katarungang Pambarangay from March 2 to April 29, 2023, at General Santos City.

This activity capacitated all the barangays in the Province of Cotabato. In partnership with the Liga ng mga Barangay Provincial Federation of Cotabato Chapter, the said activities were conducted per cluster. The DILG Cotabato also issued a provincial memorandum with regards to the said training (see Annex I)









On November 30, 2023, the DILG Cotabato served as a resource person during the conduct 5th Enhanced Justice on Wheels. LGOO V Narciso M. Beceira Jr. discussed the Katarungang Pambarangay Law with a special focus on the organization of the Lupons and the implementing powers of Lupon.

A total of 480 barangays participated in the said activity led by the Provincial Government of Cotabato.

The Enhanced Justice on Wheels (EJOW) Program is a brainchild of the Supreme Court which aims to expedite the hearing of cases by streamlining the same leading to the de-clogging of the court's dockets and releasing a considerable number of Persons Deprived of Liberty (PDLs) from prison walls.

Civil Society Organizations (CSOs)/ Peoples Participation Partnership Program

On May 4, 2023, the DILG Tulunan in coordination with the partner Southern Baptist College (SBC) conducted a Focus Group Discussion (FGD) with CSOs on the Citizen Satisfaction Index System (CSIS) result for the Municipality of Tulunan. It was participated by accredited CSOs in the said municipality.

The SBC served as the main facilitator in identifying possible interventions in service delivery gaps and other vital governance mechanisms based on the result of the CSIS.



They were grouped into 3 clusters (1) Health, Support to Education, and Social Welfare (2) Governance and Response. Public Works, and Infrastructure Environmental (3) Management, Economic, Investment Promotion. The output of FGD was a list of action plans to be integrated into the LGU Citizen-driven Priority Action Plan (CPAP)



In addition, SBC officially handed over the result of CSIS to the Municipality of Tulunan during the utilization conference last May 16, 2023, at Municipal Rooftop, Tulunan.

Utilization Conference serves as a venue to present the result to LGU and formulate plans prioritizing the interventions needed through CPAP to improve delivery of basic services.

Meanwhile, DILG Cotabato Province conducted a re-orientation activity with regard to the implementation of DILG MC 2021-054 "Establishment of Civil Society Organization (CSO) Desk, and Institutionalization of People's Council in the LGUs on August 10, 2023, via Zoom platform.

The orientation took place to adhere to the directives of the said DILG MC, which mandates every LGU to establish dedicated CSO Desks and to formulate and institutionalize their respective local People's Council.

The training primarily focused on stressing the accreditation process for People's Councils. This emphasis stemmed from the inventory, which revealed a limited number of LGUs which successfully initiated the formation of People's Councils.

Joining the said activity are the Sangguniang Bayan/Panlungsod Secretaries, LGU-Designate CSO Focal Person, and the City and Municipal Local Government Operations Officers (CMLGOOs) from the 18 LGUs of the Province of Cotabato.



With that, the DILG Cotabato were able to forged partnership (see Annex II MOU) with Ha Uman Association as one of CSO partner in some of the assessment team of the province.

As of December 31, 2023, 100% of the LGUs in the Province of Cotabato established their respective CSO Desk.

Under Section 397 of the Local Government Code of 1991, barangays are mandated to conduct assembly at least twice a year. This serves as a venue to promote accountability, transparency, and interaction between barangay officials and residents.

For 2023, 100% of barangays in Cotabato Province conducted the Barangay Assembly for the 1st semester with a total of 100, 326 attendees while for 2nd semester it was suspended due to barangay election.

Child-Friendly Local Governance Audit (CFLGA)

DILG Cotabao, chairperson of PCPC-PIMTF, conducted a strategic planning on CFLGA and LCPC functionality assessment for CY 2023 last February 14, 2023, at COTGEM Hall, Capitol Compound, Amas, Kidapawan City.

LGOO III Wyndle Joy P. Peneza thoroughly discussed the guidelines, indicators, assessment schedule, and navigation of the portal. It was attended by the members of IMTF from different offices (1) PSWDO, (2) IPHO, (3) PPDO, (4) DEPED, and (5) HA UMAN Association(CSO Representative).

Moreover, as agreed during strategic planning, PCPC-PIMTF conducted a Provincial Orientation on CFLGA for City/Municipal focal persons last February 16, 2023, at COTGEM Hall, Capitol Compound, Amas, Kidapawan City.

The LGUs were capacitated on CFLGA indicators and salient features of the portal. This activity was conducted in preparation for the audit proper and to increase the CFLGA passers in the Province of Cotabato



After the line of stringent validation of documents last March 14-15, 2023 the PIMTF conducted the calibration of results on CY 2022 CFLGA on March 30, 2023, in Sudapin, Kidapawan City.

The said calibration activity designed for the validation/review of MOVs uploaded to the online portal, along with the submission o f consolidated reports to the regional level. These reports are also used as references of the regional IMTF for their respective validation.





Likewise, the task force identified significant issues and concerns for CY 2022 implementation which will be used for future audits.

Provincial results were also presented to the Provincial Government of Cotabato through the Governor, Hon. Emmylou "Lala" Taliño-Mendoza, and the Provincial Administrator, Ms. Aurora P. Garcia.

The National Barangay Operations Office (NBOO) and Council for the Welfare of Children (CWC) issued the list of 2022 Seal of Child-Friendly Local Governance Audit Conferees last June 2023.

For Cotabato Province a total of four (4) LGUs were among the passers, namely: (1) Municipality of Alamada (89.81%), (2) Municipality of Midsayap (87.83%), (3) City of Kidapawan (86.20%), and (4) Municipality of Tulunan (83.31%).

CY 2022 SEAL OF CHILD-FRIENDLY LOCAL GOVERNANCE





Local Council for the Protection of Children (LCPC)

DILG Cotabato conducted a Provincial Orientation on CY 2023 LCPC Functionality Assessment on March 7, 2023, via Zoom Platform.

The City/Municipal Local Government Operations Officers and other Local Council for the Protection of Children (LCPC) Members were guided accordingly about the Memorandum Circular No. 2021-039 and the schedule of assessment for the year.



LCPC is a council organized at the provincial, city, municipal, and barangay levels which serves as the umbrella organization for all concerns pertaining to children.



Further, the PIMTF Cotabato conducted the On-Site Validation of the CY 2023 LCPC functionality assessment last March 21 to April 13, 2023.

The on-site validation of the LCPC highlighted the 18 city/municipal council's commendable efforts in safeguarding the welfare of children within their community.

In addition, the PIMTF anchored its functionality indicators pursuant to DILG MC 2021-039, which includes the LCPCs Organizational sustainability; Policies and Plans for Children; its Budget Utilization; and the overall Service Delivery and Management for Children.

The PIMTF were composed of the following agencies:

Chairperson	Department of the Interior and Local Government Provincial Office
Vice -Chairperson	Provincial Social Welfare and Development
Members	Provincial Planning and Development Office, Integrated Provincial Health Office, Schools Division -Department of Education, Ha Uman Association (CSO)



On March 16, 2024, the DILG Cotabato assisted during the conduct of the CY 2023 LCPC Functionality Assessment by the Regional Inter-Agency Monitoring Task Force (RIMTF) to the Provincial Government of Cotabato at Home for Women and Children, Kidapawan City.

The RIMTF evaluated the functionality of PCPC in terms of its implementation in safeguarding the interests of its children and the existing policies and plans. It was remembered that the Province of Cotabato garnered a Mature level of


functionality for CY 2022.

After a thorough review of the documents, the PCPC Cotabato was able to garner the IDEAL level of functionality and awarded with a plaque of recognition by the DILG Region XII on October 31, 2023, at EMR Center, Koronadal City during the "Pasidungog sa Dose".



The said awarding was attended by the Board Members of Cotabato Province, PSWDO, and the Provincial Director of DILG Cotabato.

Meanwhile, below are the comparative results of the City/Municipal Council for the Protection of Children from 2021-2023:



There was an increase of 28% in the number of LGUs with the IDEAL level of functionality which implies that the LGUs are providing high preference and support for the welfare of children.

Meanwhile, it was noteworthy to highlight that for CY 2023 there were no LGUs lower than Mature level of functionality anymore.

In support of the PCPC initiatives, the DILG Cotabato participated in the conduct of Formulation-Workshop on Comprehensive Emergency Plan for Children (CEPC) of Cotabato Province on September 6-7, 2023, at Parklay Suites, Kidapawan City.

It was attended by the council members and facilitated by the Department of Social Welfare and Development Region XII.



As mandated in the Republic Act 10121 also known as the "Children's Emergency Relief Protection Act", all LGUs shall ensure the safety and protection of children before, during, and after the disaster.

The DILG Cotabato was also a member of the TWG in the formulation of CEPC, as the lead agency on the Preparedness Committee.

In addition, the PCPC also conducted another capacity enhancement activity entitled "Formulation-Workshop on the Local Development Plan for Children (LDPC)" which was attended by the members of the council on October 30-31, 2023 at FCG Hotel and Restaurant, Kidapawan City.

The LDPC is a blueprint or roadmap οf actions and interventions to fulfill children's rights to survival, development, protection, participation in Province, City, Municipality, and Barangay. A three-year plan that integrated into the Provincial Development and Physical Framework Plan (PDPFP) and Comprehensive Development Plan (CDP) of the LGUs.

With that, DILG Cotabato assisted in crafting the LDPC of the province.





The Provincial Monitoring and Evaluation Team (PMET) for Governance Exemplar for Meaningful Service for Sangguniang Kabataan (GEMS for SK) conducted a Provincial Orientation for all the METs of LGUs in the Province of Cotabato last March 31, 2023.

Additionally, discussions occurred regarding the guidelines and updates provided in the DILG-XII Regional Memorandum Circular No. 2023-08. This memorandum likely contains important directives or protocols related to the assessment and evaluation of SK units, which the METs need to be aware of and adhere to in their monitoring and evaluation activities.

The DILG Cotabato facilitated the said orientation in coordination with the PYDO of Cotabato Province. The Regional Focal Person of DILG XII was also invited and serves as the Resource Person during the orientation.

It was participated by the members of the city/municipal/provincial MET, which is composed of the LYDO, DILG, Local Budget Office, Local Accountant, and CSO or student leader.



Further, the DILG Cotabato was invited during the 1st Regular Session of Cotabato Sangguniang Kabataan Provincial Federation last March 30, 2023 at Amas, Kidapawan City.

The SKPF President, Hon. Sarah Joy Simblante presided the said session and sought for the commitment of all SK officials in support to the upcoming GEMS for SK city/municipal assessment. A motion for the institutionalization of the GEMS for SK mechanism was moved thereafter through the crafting of a local ordinance in all barangays of the province.

Meanwhile, the DILG provincial focal person provided updates and shared the statistics on the 2021 and 2022 GEMS for SK implementation, including the quidance for all the SK officials.

On the other hand, the Cotabato PMET conducted its On-site Validation on GEMS for SK for CY 2023 in 18 LGUs of the Province of Cotabato from July 17 to August 24, 2023. Following the DILG-XII Regional Memorandum Circular No. 2023-08, the four (4) governance areas were carefully probed for the functionality of every Sangguniang Kabataan in every barangay. This includes Organizational Effectiveness, Development Planning, Financial Administration, and Leadership & Innovativeness.

The Sangguniang Kabataan plays a vital role in empowering youth and fostering community development. The on-site validation served as a testament to the dedication, innovation, and impact of youth leadership in community development.

Additionally, the PMET is composed of representatives from the Provincial Accounting Office, Provincial Budget Office, Provincial Youth and Development Office, CSO/Student Leader representative, and DILG Cotabato.



On September 26, 2023, the DILG Cotabato in coordination with the Provincial Government of Cotabato recognized the top performing Sangguniang Kabataan for CY 2023 in the Province of Cotabato during the SK Awards Day of Kalivungan Festival. Enhanced Comprehensive Local Integration Program (ECLIP)



DILG-Cotabato supports the weeklong conduct of the 39th Infantry (Smash 'Em) Battalion's Community Development Training in Makilala, Province of Cotabato.

The said training was conducted on January 24-30, 2023 and a total of 35 troopers have been oriented with regard to the various programs of the department.

Discussions and exercises have transpired in familiarizing the Local Government Support Fund - Support to Barangay Development Program (LGSF-SBDP), the Whole of the Nation Approach (EO 70), Ending Local Communist Armed Conflict (ELCAC), and the Enhanced Comprehensive Local Integration Program (ECLIP).

LTC Ezra L. Balagtey, INF (GSC) PA led the said training and likewise invited various lecturers from select agencies to share their respective programs. The troopers from the said battalion will be immersed thereafter to different communities sharing the programs of the government towards peace and everyone's awareness.

Meanwhile, DILG Provincial Director Ali B. Abdullah fully supports the said activity and will continue to strengthen harmonious engagements among all the sectors and units of the society.

On March 9. 2023, the DILG Province of Cotabato serves as resource speaker during the Community Support Program (CSP) training facilitated by 39th Infantry (Smash'em) Battalion, 10ID, PA in Makilala, Cotabato.



A total of 30 trainees were involved in the sharing and analyzing of the processes of the ECLIP based on DILG-DND JMC No. 2018-01 and DILG-DND JMC No. 01, s. 2021. Also, the Support to Barangay Development Program (SBDP) and the concept of the Retooled Community Support Program (RCSP) were presented for their familiarization.

The trainees have also answered several facilitated question-and-answer activities based on the said joint memorandum circulars. Likewise, the sharing of their respective queries was already facilitated in the proper administration of the Former Rebels (FRs)/ Former Violent Extremists (FVEs) package of assistance.

Lastly, the 39th IB Battalion Commander, LTC Ezra Balagtey, INF (GCS) PA, and PD Ali Abdullah of DILG Cotabato have been consistent to work hand-in-hand in implementing efficient government programs together with the local government units in all peace and order initiatives.

In 2023, the Cotabato Province has a total of 13 SBDP projects (Arakan (8), Makilala (3) and Magpet (2) funded by the NTF-ELCAC in various barangays of the province amounting to Php 79,282,586.03.

PTF-ELCAC facilitated the conduct of the turn-over ceremony of completed LGSF-SBDP Projects to the LGUs of Arakan, Magpet, and Makilala.

Cotabato Province is one of the fast implementors of the said program nationwide. Provincial Director Abdullah extended his heartfelt gratitude to the Armed Force of the Philippines who one way or another, made this program possible through the Retooled Community Support Program (RCSP).





Additionally, the DILG Cotabato assisted during the conduct of RCSP Ugnayan sa Barangay (Immersion) and Barangay Development Planning for the whole month of July 2023 in identified RCSP Barangays in the province.



RCSP is а convergence mechanism for LGUs, particularly in the barangay for the identification of issues and needed government interventions. It is anchored on the empowerment framework to develop people's capability to organize themselves and their development by bringing about valuechain interventions to uplift their current condition.

Meanwhile, Cotabato PTF-ELCAC attended the provincial dialogue conducted by the DILG Region XII on May 8, 2023 at Koronadal City. It aims to provide harmonious implementation and reporting of provincial initiatives, major accomplishments, and other issues pertaining to the said executive order.

In order to familiarize with the said systems, LGOO V Vita Gumahad presented



the DILG MC No. 2023-66 which provides for the proper protocols, forms, and documentation processes of the CY 2022 Peace and Order Council Performance Audit. Likewise, a discussion on the indicator references has transpired along with the familiarization of the POC Performance Audit System among the participants.



Meanwhile, LGOO V Laila Amanda Maha U. Sulaik presented the Anti-Drug Abuse System (ADAS) and assisted the participants on its actual usage. LGOO V Mel Roy Manait, the regional focal person also assisted the participants in dealing with concerns and technicalities of the said program.

Provincial Director Ali B. Abdullah and Outcome Manager Inecita Kionisala

supported the conduct of such activity along with other city and municipal Local Government Operations Officers and their respective focal persons from the LGUs of Cotabato.

On the other hand, the Provincial Audit Team (PAT) conducted the CY 2023 Peace and Order Council (POC) Performance Audit for Eigtheen (18) Component City/Municipal on June 14, 2023 at Park Lay Suites, Kidapawan.

The PAT delved into the POC organization, meetings, policies, plan, and budget, reports, general supervision, as well as the innovations of the LGUs.

LGUs with 100% scores were recognized during the "Pasidungog sa Dose" by the DILG XII on October 31, 2023 at EMR Center, Kidapawan City.

Moreover, LGOO V Vita V. Gumahad, POC focal person. provided technical assistance to the LGUs of Arakan and Pikit relative to the formulation of POPSP on January 18-19 and 24-26, 2023, respectively.

This activity was attended by the POC members of the said LGUs. As a result, they were able to submit the said plan to the POP-PCMS on time.



In relation to the National Task Force- Disbandment of Private Armed Groups (NTF-DPAGs) 11th Oversight Committee Meeting, the national secretariat visited the Province of Cotabato on January 30, 2023, for the conduct of a special coordination meeting with the local key functionaries.



DILG-Cotabato Outcome Manager, Inecita Kionisala and Program Manager, Vita Gumahad welcomed the team. The discussion highlighted the preparations of the team and the local functionaries for the conduct of the said national meeting to be held in Kidapawan City, Cotabato.

Moreover, the (NTF-DPAGs) conducted the 11th NTF-DPAGs Oversight Committee Meeting in Capitol Compound, Amas, Kidapawan City on May 15, 2023.

Led by the national task force chairperson, DILG Secretary Atty. Benjamin C. Abalos, Jr., the task force discussed and presented the updates on the normalization program, operation updates from Western and Eastern Mindanao, crime preventions strategies, task force work and financial plan, and likewise heard the message of the peace, reconciliation, and unity special advisers.

The said task force was organized to disband all forms of private armed groups in the Philippines and even file cases capture or committed any felonious activity. The cooperation of the members of the task force brought significant changes immediately capturing and/or in disbandment of those organized or even the newly organized illegal groups in every locality.



Participated in the presentation-discussion are the members of NTF-DPAGS, Heads of Reginal Line Agencies, Provincial Government of Cotabato, Media Partners, and the Task Force for Eastern Mindanao.

SILG Atty. Abalos congratulated and appreciated the efforts and accomplishments of all the members, especially those working on the ground. Meanwhile, a press conference was held thereafter to accommodate questions from the media especially with regard to the peace and order concern and security updates in the province along with its nearby towns.

In addition, the LGOO V Laila Amanda Maha U. Sulaik, EJOW focal person (see Annex II - Designation of Personnel) attended series of Coordination Meeting on Enhanced Justice on Wheels (EJOW) Committee from September to October in Amas, Kidapawan City.

Most people in every part of the world seek for justice. Justice, however, is sometimes delayed by the clogging of court dockets or lack of court. In response to the situation, the 'Justice on Wheels' Program was implemented.

It was adopted and launched in the Philippines in 2004. The program aimed mainly at declogging court dockets by supplying mobile complementary courts and mobile substitute courts. It was later relaunched in 2008 under the name 'Enhanced Justice on Wheels' (EJOW) Program.

The new program added mediation services and legal aid clinics for underprivileged litigants. Mobile courts were designed to travel to every place where there is no court or access to courts is highly remote. They were also made as substitute for courts which were under renovation and as complementary for those which dockets are clogging. EJOW also provide free medical and dental aid for the detainees and facilitated information dissemination drives on the justice system.

In furtherance of these commitments, the Liga ng mga Barangay (LnB) Cotabato Provincial Chapter in coordination with DILG Cotabato Province, as part of the Technical Working Group (TWG) on Barangay Affairs, will spearhead the information dissemination to the barangay officials in the Province.







During the 2nd Coordination Meeting on September 7, 2023, agenda of the meeting included discussion on the following: Component activities of the EJOW Day; Finalization of topics for the Information Dissemination through lecture between barangay officials of Cotabato Province and the Philippine Judiciary Academy; Assigning of tasks to the EJOW Technical Working Group (TWG); and addressing of concerns raised by stakeholders.

On the 3rd Coordination Meeting last October 11, 2023, Summary report of each TWG or Committee in preparation for the implementation of the program was presented. LGOO V Laila Amanda Maha U. Sulaik, Point Person (see attached Annex for Designation), presented the comprehensive plan for the conduct of Information Dissemination through lecture between barangay officials of Cotabato Province.

The aim of the activity is to capacitate barangay officials on the proper knowledge, establishment and implementation of the following:

- A. Katarungang Pambarangay Law with special focus on the organization of the Lupons and the implementing powers of Lupon;
- B. Community Service Act;
- C. Barangay Council for Protection of Children; and
- D. Barangay Agricultural and Fisheries Council

Series of coordination meeting was conducted by DILG Cotabato Province together with the Liga ng mga Barangay (LnB) Cotabato Provincial Chapter and concerned offices in preparation for the information drive from October – November 2023. Target participants, program flow, among others, were discussed during the series of meeting.

Information Drive shall be implemented by the Technical Working Group (TWG) on Barangay Affairs. For better understanding and appreciations of the various modules and activities by the participants, the following were employed – presentations, lectures/discussions through power point presentations and lectures.





During the 4th Coordination Meeting last October 17, 2023, TWGs were gathered to discuss important details regarding the preparations to be made which included: Drug testing for Persons Deprived of Liberty (PDLs); Aid distribution for PDLs to be acquitted; Disposal of Drug and Gambling paraphernalia and other important matters.

On the last coordination meeting conducted last November 10, 2023, the Pilot testing of remote court hearing via Videoconferencing was thoroughly discussed where the Supreme Court's EJOW bus will be placed in identified remote areas where the witness of the defendant or complainant are present to conduct the hearing of cases which includes personalities such as judges, lawyers, and others using the latest videoconference technology. The Province of Cotabato will be the first place in the country to use the said hearing procedure.

On November 30, 2023, the DILG Cotabato facilitated the conduct of the EJOW Program Provincial Gymnasium, Kidapawan City. The 1-day event was composed οf 8 components but simultaneously held activities:

- Ceremonial Release of PDLs
- Ceremonial Burning of Drug Exhibits and Gambling Paraphernalia, Turnover of Firearms, Explosives and Deadly Weapons
- EJOW PLUS: Livelihood and Cash Assistance to Qualified Indigent PDLs in Cotabato Province
- Proof of Concept: Videoconferencing Facility
- Jail Visitation with Medical, Dental and Legal Services
- Information Dissemination through a Lecture to Newly Elected Barangay Officials in Cotabato Province
- Dialogue Amongst the Stakeholders of the Justice Sector
- Team-building Activity of Court Personnel





This is the fifth year of the implementation of EJOW in the province which aims to expedite the hearing of cases by streamlining the same leading to the declogging of the court's dockets and provide a venue to release a considerable number of Persons Deprived of Liberty (PDLs) from prison walls which paves a way for the government to decongest the prisons.

Philippine Anti-Drugs Strategy (PADS)

The national and regional awardees of the 2022 Anti-Drug Abuse Council (ADAC) Performance Awards received their respective seal on March 9, 2023 in Koronadal City, South Cotabato.

A total of 45 LGUs were conferred with the ADAC Awards in SOCCSKSARGEN. In the Province of Cotabato, the national received awardees PhP100,000.00 cash: Kidapawan City, Municipalities of Arakan, Banisilan, Carmen, Magpet, Pigcawayan, and Pres. Roxas. While the regional awardees received Plaque of Recognition: Province of Cotabato, Municipalities of Aleosan, Libungan, Pikit, Midsayap, and M'lang.

The said awarding was attended by the LCEs, Provincial Directors, C/MLGOOs and Provincial Focal Persons. Assisted the DILG-XII Regional Director. Josephine Cabrido-Leysa, CESO III is the special guest DILG Undersecretary for Local Government Marlo L. Iringan, CESO III.





On May 4, 2023, the DILG Cotabato conducted a rollout/training on the functionality of Anti-Drug Abuse Council (ADAC) of all LGUs in the Province of Cotabato via virtual platform.

LGOO V Laila Amanda Maha U. Sulaik, ADAC Provincial focal person discussed the anti-drug abuse initiatives, such as but not limited to the following:

- A. 2022 ADAC Performance Audit MC Policy;
- B. Anti-Drug Abuse Council Functionality Monitoring System (ADAC-FMS) Walkthrough; and
- C. Anti-Drug Abuse System (ADAS) familiarization.

The participants were advised and guided accordingly on the proper uploading of all documents needed for the said audit considering the May 5 deadline set by the DILG PADS-PMO.

Several concerns were raised by the participants and addressed accordingly by the ADAC provincial and regional focal person.

Participated on the said virtual conference are the C/MLGOOs, LGU ADAC Focal Persons, and LGU ADAS Focal Persons.



Aside from virtual orientation, the DILG Cotabato conducted a face-to-face orientation for the Anti-Drug Abuse System (ADAS) utilization alongside with POC-PAS on May 9, 2023 in Brgy. Binoligan, Kidapawan City.



Participants were assisted by the DILG Regional and Provincial Office in navigating the ADAS. This hands-on training was one of the initiatives of the province to strengthen the capacity of the LGUs and increase the number of highly functional ADAC.

The activity was participated by the LGU ADAC focal persons and CMLGOOs in the province.

In addition, the DILG Cotabato facilitated the 2022 City and Municipalities ADAC Performance Audit on May 18, 2023 in Kidapawan City, Cotabato.

The Provincial Audit Team (APT) is composed of the DILG, PNP, PDEA, and two (2) accredited civil society organization (CSO) representatives which audited the 18 LGUs of the Province.

The said audit delved into 4 areas:

- A. Assess the functionality and effectiveness of local ADACs based on existing issuances and policies;
- B. Determine ADAC-initiated and/or endorsed innovations, and best practices;
- C. Create an evaluation, and assessment platform; and
- D. Recognize effective and performing ADACs.



After a thorough review of the documents, below are the results of CY 2022 Performance Audit on ADAC:

Said activity intends to assess, monitor, and promote health and wellness to the PWUDs.

In behalf of PD Ali B. Abdullah, LGOO V Laila Sulaik expressed her appreciation and gratitude to the local government of Arakan led by Hon. Jeam D. Villasor for its efforts in helping the Department achieve excellence in local governance.

The importance of a Barangay as well as the roles and functions of the Punong Barangays were emphasized. challenge was given to the Punong Barangays together with their Sangguninang Barangay members to continue what they have started and that they may do this not only for the development of each of their barangays or the municipality of Arakan but for the entire country.

The said BIDA campaign is an intensified and more holistic campaign against illegal drugs. This involves various activities which reduces the exposure and drug demand in the communities.

In support to the RA 9165 also known as "Comprehensive Dangerous Drugs Act of 2002," the DILG Region XII institutionalized

the DFW-SCP which ensures that every employees both in public and private institutions are not using illegal drugs. The assessment delved into the following indicators:

- Establishment and Institutionalization of DFWP;
- 2. Conduct of Meetings;
- 3. Conduct of Authorized Drug Testing;
- 4. Implementation of General Health and Wellness Program and EAP;
- 5. Advocacy, Education and Training;
- 6. Allocation/Utilization of Substantial amount for DFWP Implementation;
- 7. Support Mechanisms to Sub-Regional Offices or its equivalent;
- 8. Maintenance of Records and Compliance to Confidentiality;
- 9. Innovations on the DFWP Implementation;
- 10. Monitoring and Evaluation;
- 11. Compliance to Smoke-Free Environment.

These four (4) LGU awardees were able to comply with the prescribed functionality indicators in the ADAC Performance Audit and implemented antiillegal drug interventions and initiatives in support of the reduction of drug abuse in their respective municipalities.

ADAC Markers were awarded by Secretary of the Interior and Local Government Atty. Benjamin C. Abalos Jr., Catalino S. Cuy, Chairman of the Dangerous Drugs Board, Regional Director DILG RO XII Josephine Cabrido-Leysa, CESO III and other DILG Key Officials. All awardees also received an incentive amounting to Php 100,000.00.

SOCIALLY-PROTECTIVE LGUs

Locally-Funded Projects (LFPs)

The DILG Cotabato Province Technical conducted various Turn-Over Engineers Ceremony of the Local Government Support Fund (LGSF) - Financial Assistance to Local Government (FALGU), RAPID, SGLGIF Support to Barangay Development Projects (SBDP) to the different LGUs of Cotabato Province in CY 2023.



A total of 235 completed projects including infra and non-infra projects such as Farm to Market Roads, Potable Water Systems, Rehabilitation of Public Markets, Evacuation Centers, and Rehabilitation of Roads from CY 2021-2023 amounting to Php 1.5 Billion were provided to the LGUs in the province which were inspected and validated by the PDMU engineers.



Moreover, the Project Evaluation Officers o f DILG Cotabato conducted a meeting with the Cotabato Province's SubayBAYAN Focal Person to discuss updates regarding the status of PLGU's physical monitoring on May 25, 2023.

The activity provides an avenue for the PEOs to relay the current status of the PLGU in the SubayBayan portal and PLGU's

Present during the meeting are representatives from Provincial Engineer, Construction and Maintenance Division Chief, SubayBayan Focal Person, and SubayBayan Alternate Focal Person, and Provincial Planning and Development Office.

Additionally, The PEO of DILG Cotabato Province conducted a meeting with the LGU Antipas' SubayBAYAN and Resultsbased Monitoring and Evaluation of LGU Infrastructure Projects (RLIP) Alternate and Focal Persons to discuss the updates regarding the status of Locally-Funded Projects (LFPs) on June 6, 2023.



The activity provides an avenue for the PEO to relay the current status of enrolled projects on the SubayBAYAN portal. This also monitors the status of RLIP enrollment for FY 2023 and re-orient the processes to the new focal persons.

Simultaneously, DILG Technical Engineers also conducted a discussion and gathered pertinent documents to the LGU's Planning Team concerning the LPMC Functionality Assessment and was assisted by MLGOO Lucia A. Aliponga.

Further, the PEO and Technical Engineer of DILG-Cotabato conducted a series of interviews in Barangays οf Salat. Sarayan and Ilustre, Kisupaan, Roxas on June 6, 2023. This is part of the continuous monitoring implementation and impact to the identified beneficiaries.

The said barangays were beneficiaries of LGSF-SBDP FY 2022 and NTF-ELCAC for farm-to-market roads amounting to Php 4 million. The Punong Barangays expressed that since they have been part of the SBDP Progam, peace and unity reign in their places. Likewise, they have expressed words of gratitude to the National Government and the DILG.

Furthermore, the Municipalities of Libungan, Magpet, and Pres. Roxas, Cotabato Province have been awarded as Top Overall Performers (Municipalities Category), besting 51 other national finalists, in the recently concluded 2023 National SubayBAYANI Awards held at Sequoia Hotel Manila Bay, Pasay City last November 16, 2023.

In addition, LGU Pres. Roxas was among the three (3) finalists in the entire Philippines who received the Special Award for LGSF-SBDP Projects. While, LGU Pigcawayan was also recognized as national finalist from the SOCCSKSARGEN Region.

It was attended by the LCE, MLGOOs, and SubayBayan Focal Persons.



The PDMU of DILG Cotabato Province conducted a Year-End Assessment and Strategic Planning for FY 2024 in Kidapawan City last December 15, 2023.

Led by Engr. Krisnan R. Panisa, Engineer III, the Technical Engineers and Project Evaluation Officer presented and discussed the updates of their respective project assignments on

Lastly, the team carried out Strategic Planning for FY 2024. New and additional tasks were also assigned to each member. This is to set overall goals and develop plans and strategies to continuously achieve next year's goals.

• Comprehensive Social Benefits Program (CSBP)



On March 28, 2023, the DILG Cotabato provided assistance to one (1) Killed-in-Action and Wounded-in-Action (KIA-WIA) beneficiary under CSBP at Brgy. Batiocan, Libungan.

The CSBP provides different types of benefits and assistance, such as special financial assistance, scholarship, special welfare assistance, health and medical care assistance, shelter assistance, and employment assistance.

Gender and Development (GAD)

The DILG Cotabato conducted a coaching session on March 7, 2023, with LGU Makilala along with their attempt to have a GAD Seal Certification from RGADC-XII.

As guided by Republic Act No. 9710 or the Magna Carta for Women, all government instrumentalities are expected to adopt gender mainstreaming in the

in the promotion of human rights and eliminate gender discrimination in their system, structure, policies, programs, processes, and procedures. As a response, the RGADC-XII has initiated the Institutionalization of the GAD Seal Certification to Local Government Units to achieve a GAD Zone Rehiyon Dose now being amplified in various localities in the region.

The Sub-RAT (Regional Assessment Team) assisted and used certain criteria indicators and salient validate the responsiveness of the said LGU with regard to the implementation of Gender and Development (GAD), the functionality of the Local Council for Protection of Children (LCPC), functionality of Committee on Decorum and Investigation (CODI)/ Grievance Committee or other similar bodies, and whatnot.



Representatives from Cotabato-IPHO, Provincial Planning and Development Office (PPDO), Municipalit Local Government Operations Officers (MLGOO), and other local functionaries are also present to work hand-in-hand in reaching the said noble objective for the LGUs in the Province of Cotabato.





Further, LGOO V Helen D. Sayon of DILG-Cotabato attended the Gender and Development Focal Point System (GADFPS)-Technical Working Group held on January 12, 2023, at the 3rd Floor Annex Bldg., Capitol Compound, Amas, Kidapawan City.

LGOO III Aslamia K. Anggie, provincial focal person discussed the DILG-DSWD-DOJ JMC No. 2010-01; DILG MC No. 2020-006; CY 2022 LCAT-VAWC Assessment Results; and CY 2023 LCAT-VAWC Functionality Assessment tools.

Members of the city/municipality CAT-VAWC virtually participated, such as the C/MPDC, C/MSWDO, C/MHO, Chairperson of the Committee on Women, Children and Family, Sangguniang Panlungsod/Bayan, C/M PESO, C/M Prosecutor Representative, C/MLGOO, C/M COP, and CSO Representatives of the following sectors: Women, Children, and Overseas Filipino Workers.

The Provincial Inter-Agency Monitoring Team (PIMT) assessed the Functionality of LCAT-VAWC covering the CY 2022 functionality of all municipalities and city of the Province of Cotabato on March 21, 2023, to April 13, 2023.

The assessment is based on DILG Memorandum Circular No. 2020-006 which aims to strengthen the committee as the primary mechanism to address Trafficking in Person (TIP) and VAWC. The indicators covered are Organization, Meetings, Policies, Plans and Budget, and Accomplishments of the committee.



The PIMT is composed of representatives from the DILG, PSWDO, PNP, DOJ, IPHO, and Oblates of Notre Dame-Women's Ecological Sanctuary (OND-WES), as a non-government organization partner.

Ten (10) new assessors from the regional, city, and provincial offices attended the said workshop.








It was attended by the selected process owners and the assessors from different regions.



This **Me morandum of Understanding (MOU)** is made and entered into this 26th day of January, 2023 by and bet weem:

The DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DLG) COTABATO PROVINCIAL OFFICE which is mandated to strengthen local government capacities, performing oversight function over LGUs, and providing rewards and incentives, with principal office address at Capitol Compound, Amas, Kidapawan City, Cotabato and represented herein by Provincial Director Ali B Abdullah, and hereinafter referred to as the "DLG";

-and

The Halad Uma Alang sa Nasud (HaUman) Association Incorporated, an organization with the primary purpose of Child, Family and Community development program and management with office address in Midsayap, Cotabato, herein represented by its Executive Director, Joselito E Nuñez, and hereafter referred to as the "Organization";

The DLG and the "Organization" shall be herein collectively referred to as the "Parties";

W TNESSETH

WHEREAS, the DLG pursuant to its mandate to promote peace and order, ensure public safety and strengthen local government capability,

WHEREAS, the Halad Uma Alang sa Nasud (Ha Uman) Association Incorporated has been duly accredited by the Department pursuant to the requirements and criteria for accreditation stated in Memorandum Groular No. 2022-005 entitled Quiddines on the Accreditation of Gvil Society Organizations to Co-implement DLG Programs and Projects;

WHEREAS, the Organization has signified its intention to conduct activities in support of the Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC);

WHEREAS, the DLG through the Cotabato Provincial Office has deemed that Halad Uma Alang sa Nasud (HaUman) Association Incorporated possesses the qualifications, competencies, and proven track record needed to co-implement Seal of Good Local Governance (SGLG), Lupong Tagapa maya pa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC);

WHEREAS. Republic Act No. 11936 (General Appropriations Act of 2023) allows national government agencies to partner with divil society organizations (CSOs) and transfer government funds to a CSO, provided that, the CSO is accredited by the national government agency and selected in accordance with all applicable rules and regulations;

NOW THEREFORE, for and in consideration of the foregoing premises, the Parties hereby agree on the following terms and conditions:

I. ROLES AND RESPONSIBILITIES OF THE PARTIES

A DLG

The DLG, through Cotabato Provincial Office shall oversee the overall implementation of the Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC) and shall perform the following:

- Orient the Organization on the program's objectives, strategies, key messages, and other requirements and mechanics;
- Facilitate the communication and coordination between the Organization and the local government unit where an activity shall be conducted;
- iii. Direct, recommend or suggest proper or further plan of actions needed to be accomplished by the Organization in order to ensure quality, useful and efficient implementation of Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC);
- iv. Monitor the Organization's conduct of initiatives related to the Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC), and ensure that it is in accordance with the work plan agreed upon;
- v. Encourage local government units to take part in activities conducted by the Organization in support of the Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC);
- vi. Submit the Fund Utilization Report of the Organization to the DLG Accounting Division to report the utilization of the fund for recording to the book of accounts (if applicable); and
- vii. Perform other functions as may be mutually agreed upon by the Parties to ensure the success of the Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPQ).

B ORGAN ZATI ON

The Organization, as an accredited organization committed to support the DLG in the implementation of the Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC), shall:

- i. Orient its resource persons and members on the terms and conditions of the organization is partnership with the DLG in the implementation of Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPQ);
- Conduct, in partnership with the DLG assessment for the local government units for CY 2023;
- iii. The DLG will provide payment for travel expense, honoraria, and appropriate allowable per dems of the CSO member/s and guidelines on the disbursement and utilization of funds and other funding requirements;
- Ensure the conformity of the activities to the set guidelines of the DLG and the work plan agreed upon by the parties;
- v. Disseminate and assist in the circulation of DLG Information, Education, and Communication (IEC) materials on Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC);
- vi. Course all communications, concerns, and request to LGUs through the DLCG and
- vii. Perform other functions as may be mutually agreed upon by the parties to ensure the success of the Seal of Good Local Governance (SGLG), Lupong Tagapa mayapa Incentives Awards (LTIA) and Local Council for the Protection of Children (LCPC).

II. AMENDMENTS AND WAI VERS

No provision of this Agreement shall be amended, waived, discharged or terminated or ally nor may any breach of or default under any of the provisions of this Agreement be waived or discharged or ally but (in each case) only by an instrument in writing signed by or on behalf of the party against whom enforcement of the amendment waiver, discharge or termination is sought. Failure by any party to demand strict compliance with any of the terms and conditions herein stipulated shall not be construed as a waiver thereof. Any waiver shall be in writing and signed by the party making the waiver. The rights and remedies herein provided are cumulative and not exclusive of any rights and remedies provided by law or by any other agreement between the parties.

III. NOTI CES

The parties hereby agree that that their respective addresses as set forth in page one (1) of this Agree ment shall be their respective addresses for purposes of notice and demand, if any, be required under this Agreement or documents and instruments executed pursuant hereto, until and unless another address shall be formally communicated to the other party in writing.

IV TERM NATI ON AGREEMENT OR NOTICE

The DLG may, based on evidence of failure of the ORGAN ZATI ON to comply with the terms of the agreement, had its accreditation or certification revoked due to, but not limited to the grounds stated in Section 10.1 of DLG Memorandum Groular 2022-005, or in the event the ORGAN ZATI ON incurs unreasonable delay, inaction, or break of obligation under the Memorandum of Understanding, issue a notice of intent to terminate the agreement. The DLG shall give not less than fourteen (14) days written notice to the ORGAN ZATI ON of intent to terminate the grant in whole or in part. The termination notice shall establish the effective date of the termination of the grant and the amount and date of payment of any sums due either party.

If any dispute or difference of any kind whatsoever shall arise between the parties in connection with the implementation or interpretation of this contract, the parties shall make every effort to residive a micably such dispute or difference by mutual consultation.

V. SEPARABLLITY OF PROVISION

If any provision of this Understanding or any document or instrument relevant, executed or delivered pursuant hereto shall be held invalid, the remainder thereof shall not be affected thereby.

M. EFFECTI WITY CLAUSE

B. LEADERSHIP AWARDS

1. CATEGORIES OF AWARDS

1.3 Best Administrative Personnel

The award is conferred to the best performing administrative personnel who has performed well in all key areas of his or her job. The awardee consistently demonstrates exceptional performance, significantly above what is expected, and has thereby contributed to the attainment of the Department's goals and objectives through the LGRRC.

2. PRAISE COMMITTEE AND EVALUATION CRITERIA

2.1 The Provincial PRAISE Committee shall screen and evaluate eligible candidates for the TATAK AGILA, as provided in DILG Circular 2017-15.

2.2 The Performance Indicators for each award category as provided in the DILG XII's Rewards and Recognition Policy shall be used in evaluating eligible candidates for the TATAK AGILA.

3. ELIGIBILITY REQUIREMENTS

The nomination for the TATAK AGILA is open to all existing employees of DILG Cotabato that have satisfied the following eligibility requirements:

- 3.1 At least one (1) year of continuous service in the Department at the time of the nomination;
- 3.2 A performance rating of at least Very Satisfactory for the two (2) periods immediately preceding the nomination;
 - 3.3 Never been found guilty of any administrative or criminal offense.

Any employee shall not be denied nomination or the award itself because of discrimination such as ethnicity, sex, age, language, sexual orientation, religion, political affiliation, geographical origin, disability and other status.

4. NOMINATION AND SELECTION PROCEDURE

- 4.1 The Provincial PRAISE Committee shall screen the nominations and evaluate justification contained therein following the evaluation criteria provided in the DILG XII's Rewards and Recognition Policy.
- 4.2 The reckoning period of evaluation shall be the First Three Quarters (Quarter 1 to Quarter 3) of the current year at the time of the nomination.
