Contract Agreement

This **CONTRACT AGREEMENT** executed on the 13th day of October 2021 between the **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) - REGIONAL OFFICE XII** (hereinafter called the "**Entity**") and **GENERAL SANTOS REAL HOTEL DEVELOPMENT CORPORATION** with business address at Koronadal City, South Cotabato (hereinafter called the "**Supplier**"):

WHEREAS, upon request of the **Entity**, the **Supplier** submitted a price quotation for the procurement of goods and services (**VENUE, MEALS, SNACKS AND ACCOMMODATION**) for the "**CONDUCT OF THE PROVISION OF TECHNICAL ASSISTANCE ON MAINSTREAMING DRR-CCAM TO THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) ON OCTOBER 14-15, 2021 AND OCTOBER 21-22, 2021**" in the amount of **One Hundred Sixty Eight Thousand Four Hundred Forty Pesos (Php168,440.00)** inclusive of all applicable taxes and other fees (hereinafter called the "**Contract Price**"), which the **Entity** subsequently accepted pursuant to Bids and Awards Committee Resolution No. **NP2021-10-003**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- The following documents shall form part of this Agreement in accordance with Section 37.2.3 of the Revised Implementing Rules and Regulations of RA 9184, viz:
 - The **Entity's** Request for Quotation dated 11 October 2021, attached as **Annex A**;
 - The **Supplier's** Proposal dated 12 October 2021, attached as **Annex B**; and
 - The **Entity's** Notice of Award, attached as **Annex C**.
- In consideration of the payment to be made by the **Entity** to the **Supplier** as hereinbefore mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and services, and remedy the defects thereof prior to the activity or immediately as the circumstances may allow from Notice, in conformity with the stipulations of the Contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
- The **Entity** hereby covenants to pay the **Supplier** the Contract Price in consideration of the provision of the supplies and materials and remedying the defects thereof.
