Contract of Services

This **CONTRACT OF SERVICE** is made and entered into this 9th day of February 2022 in Koronadal City, South Cotabato Province, Philippines, by and between the **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) - REGIONAL OFFICE XII** (hereinafter referred to as the "**First Party**")

AFL 168 CORPORATION, represented herein by **Ms. Lorna T. Lagos, Proprietor**, with business address at Brgy. Morales, Koronadal City (hereinafter referred to as the "**Second Party**");

WITNESSETH

WHEREAS, the First Party will conduct a three (3) day activity entitled "**STRATEGIC PLANNING WORKSHOP ON ELCAC AND OTHER DILG MAJOR PROGRAMS AND REGIONAL CONSULTATION DIALOGUE WITH MANCOM AND OUTCOME/PROGRAM MANAGERS**" on February 15-17, 2022;

WHEREAS, the Second Party has the capability of providing venue, accommodation and food for the conduct of the above-mentioned activity at reasonable cost;

NOW, THEREFORE, for and in consideration of the foregoing premises the parties hereto agree the contents of this Contract to wit:

1. That the **Second Party** agrees and binds itself to the **First Party**, to provide venue, accommodation and food for the participants who will attend the "**STRATEGIC PLANNING WORKSHOP ON ELCAC AND OTHER DILG MAJOR PROGRAMS AND REGIONAL CONSULTATION DIALOGUE WITH MANCOM AND OUTCOME/PROGRAM MANAGERS**" on February 15-17, 2022 with the Approved Budget for the Contract (ABC) of One Hundred Thirty Eight Thousand Pesos (**Php 138,800.00**) as indicated in the approved Activity Design subject to the qualification that only the actual cost/billing of the **Second Party** shall be paid by the **First Party** appearing in the Statement of Account inclusive of all applicable taxes and other fees (hereinafter called the "**Contract Price**"), which the **Second Party** subsequently accepted pursuant to Bids and Awards Committee Resolution No. **LOV2022-02-001**;
2. The following documents shall form part of this Contract in accordance with Number 9 of Annex H of the 2016 Revised Implementing Rules and Regulations of RA 9184, providing the provisions on Lease of Venue, Accommodation and Food;

 - (b) The **Supplier's** Proposal dated 07 February 2022, attached as **Annex B**; and
 - (c) The **Entity's** Notice of Award, attached as **Annex C**.

In consideration of the payment to be made by the **First Party** to the **Second Party** as hereinbefore mentioned, the **latter** hereby covenants with the **former** to provide the venue, accommodation and food, and to immediately remedy the defects thereof from Notice, in conformity with the stipulations of this Contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws;
4. The **First Party** hereby covenants to pay the **Second Party** the Contract Price in consideration of the lease of the venue, accommodation and food and remedying the defects thereof; and
5. The **Second Party** hereby covenants to ensure that disinfection of the venue is undertaken prior to the activity, and provide sufficient space for the participants, such that the 1 meter social distancing may be implemented.
