## BAC Resolution No. 2017-01-004

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO HILITE SECURITY AGENCY, INC. FOR THE PROCUREMENT OF SECURITY SERVICES IN THE GONTRACT AMOUNT OF THREE HUNDRED SIXTEEN THOUSAND TWO HUNDRED FIFTY PESOS (Php 316,250.00)

WHEREAS, the expiring one month extension (January 2017) of the contract of services by the agency providing security for the DILG Regional Office XII was presented for the DILG XII BAC for deliberation;

WHEREAS, it is provided in DILG XII's Annual Procurement Plan (APP) for CY 2017 that a total amount of Three Hundred Forty-Eight Thousand Pesos (Php348, 000.00) was allocated for the payment of security services for the office;

WHEREAS, considering that DILG XII will require the renewal of security services from 01 February 2017 to 31 December 2017 or a total of eleven (11) months, a total of Three Hundred Nineteen Thousand Pesos (Php319, 000.00) has been allocated as the approved budget for the contract (ABC);

WHEREAS, under Section 53.9, in relation to Section 48.1 of the Revised Implementing Rules and Regulations of Republic Act 9184, provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed Php500, 000.00

WHEREAS, on the 16<sup>th</sup> of January 2017 the DILG-XII BAC published the Request for Proposal/Quotation of the said project and that the following suppliers were also invited to submit their proposal/quotations: 1. Supreme Investigative & Security Agency; 2. Crown Security Agency; and 3. Hilite Security Agency, Inc.;

WHEREAS, the following are the offered proposal/quotation of the interested bidders:

- 1. Supreme Investigative & Security Agency Php316, 800.00
- 2. Crown Security Agency Php317, 900.00
- 3. Hilite Security Agency, Inc. Php316, 250.00

WHEREAS, upon deliberation and post qualification the DILG XII BAC, the offer of *Hilite Security Agency, Inc.* was found compliant to the terms of reference as provided in the Request for Quotation/Proposal;


