**Recommending the Award of Contract to SARANGANI HIGHLANDS GARDEN for the Lease of Venue, including Accommodations and Meals in the conduct of National Disaster Preparedness Plan Localization Sessions (Regional Disaster Preparedness Planning Workshop) – Component 1 in the total amount of Eighty Eight Thousand Three Hundred Twenty Pesos (Php 88,320.00)**

**WHEREAS**, the DILG-XII's Office of the Regional Director (ORD) is in charge of the prepared and submitted Terms of Reference (TOR) for the lease of venue, including accommodations and meals for the conduct of "*National Disaster Preparedness Plan Localization Sessions (Regional Disaster Preparedness Planning Workshop) – Component 1* with an approved budget for the contract (ABC) in the amount of One Hundred Ten Thousand Four Hundred Pesos (Php 110,400.00);

**WHEREAS**, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's annual procurement plan (APP);

**WHEREAS**, in accordance with GPPB Resolution No. 08-2009 "Implementing Guidelines for the Lease of Privately-owned Real Estate and Venue and pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

**WHEREAS**, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

1. Sarangani Highlands Garden – Php 88,320.00
2. Anchor Hotel – Php 96,600.00 (Preferred date is not available)
3. London Beach Resort and Hotel, Inc. – Php 95,220.00

**WHEREAS**, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by *Sarangani Highlands Garden* is the lowest calculated responsive bid and offers the most advantageous price and arrangements for DILG;




