WHEREAS, the DILG-XII's Office of the Regional Director (ORD) is in charge of the prepared and submitted Terms of Reference (TOR) for the procurement of Printing Services for the DILG XII Annual Report CY 2016 issue with an approved budget for the contract (ABC) in the amount of One Hundred Thirty Thousand and Five Centavos Only (Php 130,000.05);

WHEREAS, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's annual procurement plan (APP);

WHEREAS, in accordance with GPPB Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

- 1. KING PHIL PRINTING SERVICES Php 81,252.50
- 2. ST. ANTHONY PRESS Php 129,500.00
- 3. PAGHIDAIT PRINTING PRESS Php 105,000.00
- 4. MARBEL GEPCARS PRINTING PRESS Php 122,500.00

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by *King Phil Printing Services* is the lowest calculated responsive bid and offers the most advantageous price and arrangements for DILG;


