Recommending the Award of Contract to THE FARM @ Carpenter HILL for the Lease of Venue, including Accommodations and Meals in the conduct of Enhanced Business Permit and Licensing System (BPLS) for Regulatory Simplification for Local Governments (RS4LG): Paving the Way for Doing Business in a Breeze in the total amount of Eighty Seven Thousand Four Hundred Pesos (Php 87,400.00)

WHEREAS, the DILG-XII's Local Government Capability Development Division (LGCDD) is in charge of the prepared and submitted Terms of Reference (TOR) for the lease of venue, including accommodations and meals for the conduct of "*Enhanced Business Permit and Licensing System (BPLS) for Regulatory Simplification for Local Governments (RS4LG): Paving the Way for Doing Business in a Breeze*" with an approved budget for the contract (ABC) in the amount of Ninety Two Thousand Pesos (Php 92,000.00);

WHEREAS, in accordance with GPPB Resolution No. 08-2009 "Implementing Guidelines for the Lease of Privately-owned Real Estate and Venue and pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

1. The Farm@Carpenter Hill – Php 87,400.00
2. Villa Amor Hotel – Php 91, 080.00
3. AFL 168 – Php 67,400.00 – (Note: Rooms can accommodate 24 participants only.)

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by *The Farm@Carpenter Hill* is the lowest calculated responsive bid and offers the most advantageous price and arrangements for DILG;
