Contract Agreement

This CONTRACT AGREEMENT executed on the 19th day of April 2017 between the DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT XII (DILG-XII) (hereinafter called the "Entity" and The Farm@Carpenter Hill with business address at Carpenter Hill (hereinafter called the "Supplier"):

WHEREAS, upon request of the Entity, the Supplier submitted a price quotation for the procurement of lease of venue, including accommodations and meals for the conduct of Enhanced Business Permit and Licensing System (BPLS) for Regulatory Simplification for Local Governments (RS4LG): Paving the Way for Doing Business in a Breeze via Small Value Procurement in the amount of Eighty Seven Thousand Four Hundred Pesos (Php 87,400.00 inclusive of all applicable taxes and fees (hereinafter called the "Contract Price"), which the Entity subsequently accepted pursuant to Bids and Awards Committee Resolution No. 2017-04-020.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. The following documents shall form part of this Agreement in accordance with Section 37.2.3 of the Revised Implementing Rules and Regulations of RA 9184, viz:
 - (a) The Entity's Request for Quotation dated 12 April 2017, attached as Annex A;
 - (b) The Supplier's Proposal dated 17 April 2017, attached as Annex B; and
 - (c) The Entity's Notice of Award, attached as Annex C.
- 2. In consideration of the payment to be made by the Entity to the Supplier as hereinbefore mentioned, the Supplier hereby covenants with the Entity to provide the goods, and remedy the defects thereof in conformity with the stipulations of the Contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
- The Entity hereby covenants to pay the Supplier the Contract Price in consideration of the provision of the goods and remedying the defects thereof.
