

Recommending the Award of Contract to <u>PARAISO VERDE HOTEL</u> for the Lease of Venue, including Accommodations and Meals in the conduct of <u>Basic Gender and Development (GAD) Orientation</u> in the total amount of <u>Sixty Four Thousand Six Hundred Twenty</u> Pesos (Php <u>64,620.00</u>)

WHEREAS, the DILG-XII's Local Government Capability and Development Division (LGCDD) is in charge of the prepared and submitted Terms of Reference (TOR) for the lease of venue, including accommodations and meals for the conduct of "Basic Gender and Development (GAD) Orientation with an approved budget for the contract (ABC) in the amount of Ninety One Thousand Two Hundred Pesos Only (Php 91,200.00);

WHEREAS, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's annual procurement plan (APP);

WHEREAS, in accordance with GPPB Resolution No. 08-2009 "Implementing Guidelines for the Lease of Privately-owned Real Estate and Venue and pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

- 1. VILLA AMOR HOTEL Not Available
- 2. PARAISO VERDE HOTEL Php 64,200.00
- 3. THE FARM@CARPENTER HILL Php 87,300.00
- 4. AFL 168 Venue Not Available

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by PARAISO VERDE HOTEL is the lowest calculated responsive bid and offers the most advantageous price and arrangements for DILG;
