Recommending the Award of Contract to AGUA FRIO GARDEN RESORT, INC. for the Lease of Venue, including Meals in the conduct of Orientation on the Management of the Dead and the Missing in the total amount of Fifty Nine Thousand Four Hundred Pesos (Php 59,400.00)

WHEREAS, the DILG-XII's Office of the Regional Director (ORD) is in charge of the prepared and submitted Terms of Reference (TOR) for the lease of venue, including accommodations and meals for the conduct of "*Orientation on the Management of the Dead and the Missing*" with an approved budget for the contract (ABC) in the amount of Sixty Thousand Pesos (Php 60,000.00);

WHEREAS, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's annual procurement plan (APP);

WHEREAS, in accordance with GPPB Resolution No. 08-2009 "Implementing Guidelines for the Lease of Privately-owned Real Estate and Venue and pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

2. Villa Amor Hotel – Note: Not Available
3. The Farm@Carpenter Hill – Php 72,000.00
4. Agua Frio Garden Resort, Inc. – Php 59,400.00
5. FB Hotel – Php 48,000.00 (Note: PM Snacks is Not Available)




