BAC Resolution No. <u>2017-05-030-C</u>

Recommending the Award of Contract to FAMILY COUNTRY HOTEL & CONVENTION CENTRE for the meals and room accommodation in the conduct of Workshop on Municipal Water Supply, Sewerage, and Sanitation Sector Plan (MW4SP) Preparation in the total amount of Three Hundred Nineteen Thousand Forty Pesos (Php 319,040.00)

WHEREAS, the DILG-XII's Office of the Regional Director (ORD) — Project Development Monitoring Unit (PDMU) is in charge of the prepared and submitted Terms of Reference (TOR) for the procurement of meals and room accommodation for the conduct of "Workshop on Municipal Water Supply, Sewerage, and Sanitation Sector Plan (MW4SP) Preparation" with an approved budget for the contract (ABC) in the amount of Three Hundred Thirty Two Thousand Eight Hundred Pesos (Php 332,800.00);

WHEREAS, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's annual procurement plan (APP);

WHEREAS, in accordance with GPPB Resolution No. 13-2016 dated August 9, 2016 "Implementing Guidelines for Small Value Procurement pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

- 1. VENUE 88 RESORT AND EVENTS PLACE CORP.- Php 296,320.00
- 2. FAMILY COUNTRY HOTEL & CONVENTION CENTRE Php 319,040.00
- 3. DAMOSA LAND, INC. Php 312,320.00
- 4. GREENLEAF HOTEL GENSAN Php 299,200.00

WHEREAS, on June 9, 2017, Venue 88 Resort and Events Place Corp. cannot accept the award due to fully booked in the room accommodation of their hotel on July 4-7, 2017, therefore, the BAC awarded the contract to the second (2nd) lowest bidder, the Greenleaf Hotel Gensan with a bid proposal amounting to Php 299,200.00 for the project. However, the Greenleaf management submitted a letter dated June 14, 2017 states that they cannot accept the award for the said activity (see attached letter), so the BAC has re-awarded the contract to the third (3rd) lowest bidder, Damosa Land, Inc. with a bid proposal to Php 312,320.00 for the

project. But, again, Damosa Land, Inc. submitted a letter dated June 19, 2017 informing the BAC that upon review of the technical specifications stipulated in the TOR, they cannot accept the award (see attached letter);

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by FAMILY COUNTRY HOTEL & CONVENTION CENTRE, the fourth (4th) lowest calculated responsive bid, has found to be compliant with the terms of reference (TOR) of the project due to the withdrawal of Venue 88 Resort and Events Place Corp., Greenleaf Hotel Gensan, and Damosa Land, Inc. for the said event;

NOW, THEREFORE, in view of the foregoing, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to RECOMMEND the AWARD OF CONTRACT to FAMILY COUNTRY HOTEL & CONVENTION CENTRE for the procurement of meals and room accommodation for the conduct of "Workshop on Municipal Water Supply, Sewerage, and Sanitation Sector Plan (MW4SP) Preparation";

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the DILG XII Regional Director for his information and appropriate action;
